Rules dated 6th May, 1948, made by the Governor of Northern Ireland under sections seven and nine of the Probation of Offenders Act, 1907.

- I, WILLIAM SPENCER, EARL GRANVILLE, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable-Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, in pursuance of the provisions of sections seven and nine of the Probation of Offenders Act, 1907, and of all other powers thereunto me enabling, do hereby make the following Rules:—
- 1. The following Rule shall be substituted for Rule 19 of the Probation Rules (Northern Ireland), 1928:
 - 19.—(1) The salaries of full-time Probation Officers appointed for the Petty Sessions District of Belfast shall be as follows:—
 - (a) Principal Probation Officer—£300 per annum exclusive of War Bonus

Men Probation Officers —£240 per annum exclusive of War Bonus

Women Probation Officers —£240 per annum exclusive of War Bonus

with effect in each case from the 21st June, 1946.

- (b) Men Probation Officers —£350 inclusive
 Women Probation Officers —£335 inclusive
 with effect in each case from the 1st December, 1947.
- (2) Part-time Probation Officers appointed for the Petty Sessions Districts of Belfast and Londonderry and persons not being Probation Officers named in Probation Orders shall be entitled to be remunerated in accordance with the following scale:—

For each case appearing in the quarterly claim up to and including five in number, 12/- per quarter.

For each additional case appearing in the quarterly claim up to and including twenty in number, 9/- per quarter.

For each additional case appearing in the quarterly claim after twenty, 6/- per quarter.

In the case of part-time Probation Officers appointed for other Petty Sessions Districts the above remuneration shall be increased by twenty-five per centum."

- 2. The Rules under the Probation of Offenders Act, 1907, made on the 28th September, 1945, are hereby revoked.
- These Rules may be cited as the Probation Rules (Northern Ireland), 1948.

REGULATIONS, DATED THE 26TH JUNE, 1948, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE PUBLIC HEALTH (IRELAND) ACT, 1878, THE PUBLIC HEALTH ACT, 1896 AND THE Public Health (Regulations as to Food) Act, 1907.

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred upon it by the Public Health (Ireland) Act, 1878 (a), the Public Health Act, 1896 (b), the Public Health (Regulations as to Food) Act, 1907 (c), and of all other powers enabling it in that behalf, hereby makes the following Regulations:-

The Public Health (Imported Food) Regulations, 1937 (d), shall be amended by inserting in paragraph (c) of the First Schedule thereto (which Schedule specifies the kinds of oversea meat which may not be imported into Northern Ireland for sale for human consumption) after the word "meat" where it first appears the words "other than mutton and lamb."
