

1. For Article 11 (4) (a) there shall be substituted

(a) Movable-comb hive

BEES :— For each frame of comb fully covered with live bees ten shillings, subject to a maximum of eighty shillings.

For each frame of comb not fully covered with live bees such lesser sum as is reasonably proportionate to the area of the frame which in the opinion of the authorised officer is covered with live bees.

APPLIANCES :—Frames, eightpence each.

Sections, threepence halfpenny each.

2. These Regulations shall come into operation on the eleventh day of May, 1948.

3. These Regulations may be cited as the Bee Pest Prevention (Amendment) (Northern Ireland) Regulations, 1948, and shall be construed as one with the principal Regulations and the principal Regulations and these Regulations may together be cited as the Bee Pest Prevention (Revised) (Northern Ireland) Regulations, 1948.

REGULATIONS, DATED 12TH JUNE, 1948, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE BEE PEST PREVENTION ACT (NORTHERN IRELAND) 1945, (1945 C. 1.).

1948. No. 149

The Ministry of Agriculture in exercise of the powers conferred upon it by the Bee Pest Prevention Act (Northern Ireland) 1945, and of every other power enabling it in that behalf hereby makes the following Regulations by way of amendment of the Bee Pest Prevention (Northern Ireland) Regulations, 1945, (hereinafter referred to as the principal regulations) :—

1. For Article 2 there shall be substituted —

The following are hereby specified as the pests and diseases to which the Act and these Regulations shall apply, viz. :

American Foul Brood ;

European Foul Brood ;

Acarine (Isle of Wight) Disease, and

Nosema Disease.

2. These Regulations shall come into operation on the 12th day of June, 1948.

3. These Regulations may be cited as the Bee Pest Prevention (Amendment) (No. 2) Regulations (Northern Ireland), 1948, and shall be construed as one with the principal Regulations, and the principal Regulations, the Bee Pest Prevention (Amendment) (Northern Ireland) Regulations, 1948, and these Regulations may together be cited as the Bee Pest Prevention Regulations (Northern Ireland) 1945-1948.

BUILDING SOCIETY

REGULATIONS MADE THE 5TH DAY OF FEBRUARY, 1948, UNDER THE BUILDING SOCIETY ACTS (NORTHERN IRELAND), 1874 TO 1940.

1948. No. 22

In pursuance of the powers vested in us respectively by the above-mentioned Acts, and by the Government of Ireland Act, 1920 (a), and the General Adaptation of Enactments Order, 1921 (b), and of all other powers in that behalf, we, the Right Honourable Sir Roland Nugent, Minister of Commerce, except as hereinafter mentioned and the Registrar of Building Societies for Northern Ireland (hereinafter referred to as the Registrar), in respect of the forms mentioned in paragraphs 4 and 5 below, hereby make the following regulations :—

1. Where two or more building societies unite, notice shall be given to the Registrar in duplicate in Form AQ set out in the Schedule hereto, and the Registrar shall return one copy to the united society endorsed with the word "Registered" and duly authenticated.

2. Where a building society transfers its engagements to another, notice shall be given to the Registrar in duplicate in Form AR, set out in the Schedule hereto, and the Registrar shall return one copy to the transferee society, endorsed with the word "Registered" and duly authenticated.
