

THE CATERING ESTABLISHMENTS (REGISTRATION CERTIFICATES) REGULATIONS, 1948, DATED 28TH JUNE, 1948, MADE BY THE MINISTRY OF COMMERCE UNDER SECTION 13 OF THE DEVELOPMENT OF TOURIST TRAFFIC ACT (NORTHERN IRELAND), 1948.

1948. No. 165

1. The Ministry of Commerce in pursuance of the powers conferred on it by Section 13 of the Development of Tourist Traffic Act (Northern Ireland) 1948 and of every other power in that behalf it thereunto enabling hereby prescribes that a Certificate of Registration issued by the Northern Ireland Tourist Board shall be in such one of the forms set out in the Schedule hereto as shall be appropriate to the Catering Establishment therein mentioned.

2.—(a) These Regulations may be cited as the Catering Establishments (Registration Certificates) Regulations (Northern Ireland), 1948.

(b) The Interpretation Act 1889 as in force in Northern Ireland shall apply to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

TRADE UNION

REGULATIONS MADE THE 5TH DAY OF FEBRUARY, 1948, UNDER THE TRADE UNION ACTS (NORTHERN IRELAND), 1871 TO 1940.

1948. No. 23

In pursuance of the powers vested in us respectively by the above-mentioned Acts and by the Government of Ireland Act, 1920 (a) and the General Adaptation of Enactments Order 1921 (b), and of all other powers in that behalf, we, the Right Honourable Sir Roland Nugent, Minister of Commerce, except as hereinafter mentioned, and the Registrar of Friendly Societies for Northern Ireland, (hereinafter referred to as the Registrar) in respect of the forms mentioned in paragraphs 2 and 3 below, hereby make the following Regulations :—

1. Notice of every transfer of engagements under section 5 of the Societies (Miscellaneous Provisions) Act (Northern Ireland), 1940 (c), shall be given in duplicate to the Registrar by the trade union transferring its engagements in Form V set out in the Schedule hereto accompanied by statutory declarations in Forms W and X set out in the Schedule hereto and by a fee of £1. The Registrar shall return one copy of the notice to the transferee society endorsed with the word "Registered" and duly authenticated.

2. An application made under section 5 (2) of the above Act shall be in Form Y set out in the Schedule hereto and shall be accompanied by a fee of £5.
