- To determine the balance of income the following deductions may be made from the gross income :-

 - (i) an allowance of £50 per annum in respect of each wholly dependent son or daughter of the parent excluding the applicant;
 (ii) expenditure which, in the opinion of the Ministry, is reasonably incurred by the parent on the education of members of the family;
 - (iii) mortgage interest payable in respect of property held by the parent;
 - (iv) exceptional items of expenditure at the discretion of the Ministry.
- 5. To determine the gross income, receipts under the following heads for the preceding financial year shall be taken into account:

(i) earned and unearned income of both parents;

- family allowances payable under the Unemployment and Family
- Allowances (Northern Ireland Agreement) Act, 1946;

 (iii) endowment scholarships and other awards held by members of the family, and any sums contributed by relatives or other persons towards the cost of educating members of the family;

(iv) the annual value of any property held by the parent.

The value of a scholarship shall, where necessary, be adjusted from that shown in the table so that the balance of income less the contribution is not reduced below what it would have been if the balance of income had fallen at the highest point in the next lower group.

- (2) In these Regulations the expression "the principal Regulations" means the Electoral (Register of Electors) Regulations (Northern Ireland), 1946.

- 2. The following Regulation shall be substituted for Regulation 5 of the principal Regulations:—
- "5.—(1) As soon as may be after the 31st October, 1948, and in any Service list case not later than 1st January, 1949, the Clerk of the Crown and Peace for 1949 for each County and County Borough shall supply to the Electoral Officer a list of those persons who on the 31st October, 1948, were, according to his records, qualified to be Service electors at a Parliamentary election held under the Wartime Registration Acts, 1943-44, by virtue of declarations made by such persons under the said Acts and in force on the said 31st October.
