

(2) The Interpretation Act, 1921, shall apply for the purposes of the interpretation of this Order in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. The Mental Health (Transfer of Functions) Order (Northern Ireland), 1948, shall have effect, and shall be deemed always to have had effect, as if in section four of the Poor Afflicted Persons Relief (Ireland) Act, 1878 :—

(a) for reference to " pauper " there were substituted references to " person " ;

(b) the words " out of the rates " were omitted.

REGULATIONS DATED THE 31ST DAY OF DECEMBER, 1948, MADE BY THE
MINISTRY OF COMMERCE UNDER THE MOTOR VEHICLES AND ROAD
TRAFFIC ACTS (NORTHERN IRELAND), 1926 TO 1945.

1948. No. 343

The Ministry of Commerce, in exercise of the powers vested in it by the Motor Vehicles and Road Traffic Acts (Northern Ireland), 1926 to 1945, and of all other powers in this behalf thereunto enabling it, hereby makes the following regulations further amending the Motor Cars (Use and Construction) Regulations, 1934 (a) (hereinafter referred to as the "principal regulations"), that is to say :—

1. Article 46 of the principal regulations as amended shall be read and have effect as if in the proviso thereto the date " 1st January, 1950 " were substituted for the date " 1st January, 1949 ".

2. Article 47 of the principal regulations as amended is hereby revoked.

3. Article 48 of the principal regulations as amended shall be deleted and the following article substituted therefor :—

48. All the wheels of a trailer when the trailer is being drawn on a public road by a motor car or a heavy motor car shall be equipped with pneumatic tyres :

Provided that this Regulation shall not apply to —

- (a) trailers designed for use in works or on private premises and used on a road only in passing from one part of the works or premises to another or to works or premises in the immediate neighbourhood, or to trailers designed and used by or on behalf of local authorities for street cleansing or the collection or disposal of refuse ;
- (b) any land implement or any agricultural trailer fitted with wooden or metal tyres which are smooth soled and which where the tyre touches the surface of the road are not less than 3 inches in width.

4. These Regulations may be cited as the Motor Cars (Use and Construction) (Amendment) (Northern Ireland) Regulations, 1948.

REGULATIONS, DATED 15TH DAY OF JUNE, 1948, MADE BY THE MINISTRY OF COMMERCE UNDER PART II OF THE MOTOR VEHICLES (TRAFFIC AND REGULATION) ACT (NORTHERN IRELAND), 1926.

The Ministry of Commerce in exercise of the powers vested in it by Part II of the Motor Vehicles (Traffic and Regulation) Act (Northern Ireland), 1926, and of all other powers in that behalf thereunto enabling it, hereby makes the following Regulations, further amending the Public Service Vehicles Regulations, 1927 (a), (hereinafter referred to as "the Principal Regulations"), that is to say :—

1. Article 17 (4) of the Principal Regulations, as amended by Article 3 of the Public Service Vehicles (Amendment) Regulations, 1947 (b), is hereby revoked and the following Article shall be substituted therefor
