WHEREAS the Ministry of Labour and National Insurance (hereinafter referred to as "the Ministry") has received from the Baking Wages Council (Northern Ireland) wages regulation proposals for the revocation of the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 1) Order, 1948, (a) dated the 3rd day of November, 1948, and for the further amendment of the Baking Wages Council (Northern Ireland) Wages Regulation (No. 6) Order, 1948, (b) dated the 11th day of August, 1948, (hereinafter referred to as "Order N.I.Bk. (67)") which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates;

Now, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order:—

Statutory minimum remuneration.

As from the specified date Order N.I.Bk. (67) as amended shall have effect subject to the further amendments set out in the Schedule to this Order.

Commencement. ·

In this Order the expression "the specified date" means the 27th day of December, 1948. Provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.

Short title, interpretation and revocation.

- 3.—(1) This Order may be cited as the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 5) Order, 1948.
- (2) The Interpretation Act, 1921, applies to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- (3) As from the specified date the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 1) Order, 1948, (c) dated the 3rd day of November, 1948, is hereby revoked.

#### SCHEDULE

STATUTORY MINIMUM REMUNERATION FOR CERTAIN MALE WORKERS EMPLOYED IN AREA A, THAT IS, IN ESTABLISHMENTS (OTHER THAN HOME BAKERIES) IN THE COUNTY BOROUGH OF THE CITY OF BELFAST AND IN DISTRICTS SITUATE WITHIN A RADIUS OF 15 STATUTE MILES THEREFROM.

The Baking Wages Council (Northern Ireland) Wages Regulation (No. 6) Order, 1948 (Order N.I.Bk. (67)) shall have effect as if, in the Schedule thereto, for paragraph 1 (a) thereof (which was added thereto by the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 1) Order, 1948 (Order N.I. Bk. (73)) there were substituted the following paragraph:—

### ADDITIONAL PAYMENTS FOR CERTAIN MALE WORKERS

# "PARAGRAPH 1(A)

The general minimum time rates applicable to the classes of workers described in sub-paragraph (1) (a), (b), (c), (d), (e) and (f) of paragraph 1 of this Schedule and set out in Cols. 2 and 8 of the table in that paragraph shall be increased by the additional amounts specified hereafter, namely—

In the case of journeymen bakers, doughmakers,

ovensmen and confectionery mixers ... by 6s. 0d. per week of 45 hours. In the case of jobbers ... by 1s. 0d. for each week-day. In the case of apprentice bakers ... by 2s. 6d. per week of 45 hours.

Provided that the aforesaid additional amounts shall not be taken into account for the purpose of the calculation of statutory minimum remuneration due to such workers in respect of time worked in excess of the normal working day or of the normal working week nor in the calculation of holiday remuneration and the Baking Wages Council (Northern Ireland) Wages Regulation (Holidays) Order, 1948 shall have effect accordingly."
