THE BAKING WAGES COUNCIL (NORTHERN IRELAND) WAGES REGULATION (AMENDMENT) (NO. 7) ORDER, 1948, DATED 20TH DECEMBER, 1948, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 10 OF THE WAGES COUNCILS ACT (NORTHERN IRELAND), 1945 (9 & 10 GEO. 6, CH. 21).

WHEREAS the Ministry of Labour and National Insurance (hereinafter referred to as “ the Ministry ”) has received from the Baking Wages Council (Northern Ireland) wages regulation proposals for the revocation of the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 3) Order, 1948, (a) dated the 3rd day of November, 1948, and for the further amendment of the Baking Wages Council (Northern Ireland) Wages Regulation (No. 8) Order, 1948, (b) dated the 11th day of August, 1948, (hereinafter referred to as “ Order N.I.Bk. (69) ”) which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates ;

Now, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order :—

1. As from the specified date Order N.I.Bk. (69) as amended shall have effect subject to the further amendments set out in the Schedule to this Order. Statutory minimum remuneration.

2. In this Order the expression “ the specified date ” means the 27th day of December, 1948. Provided that where, as respects any Commencement.

3.—(1) This Order may be cited as the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 7) Order, 1948.

(3) As from the specified date the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 3) Order, 1948, (a) dated the 3rd day of November, 1948, is hereby revoked.

STATUTORY MINIMUM REMUNERATION FOR CERTAIN MALE WORKERS EMPLOYED IN AREA C, THAT IS, IN ESTABLISHMENTS (OTHER THAN HOME BAKERIES) IN AREAS OTHER THAN THE COUNTY BOROUGH OF THE CITY OF BELFAST AND IN DISTRICTS SITUATE WITHIN A RADIUS OF 15 STATUTE MILES THEREFROM, AND THE COUNTY BOROUGH OF THE CITY OF LONDONDERY.
