2. In this Order the expression "the specified date" means the 6th day of January, 1950. Provided that where, as respects any worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date. STATUTORY MINIMUM REMUNERATION FOR MALE WORKERS EMPLOYED IN AREA C, that is, IN ESTABLISHMENTS (OTHER THAN HOME BAKERIES) IN AREAS OTHER THAN THE COUNTY BOROUGH OF THE CITY OF BELFAST AND IN DISTRICTS SITUATE WITHIN A RADIUS OF 15 STATUTE MILES THEREFROM AND THE COUNTY BOROUGH OF THE CITY OF LONDONDERRY.

Order N.I.Bk. (91), as amended, shall have effect as if in paragraph 2 of the Schedule thereto the words "nor in the calculation of holiday remuneration" were deleted.

THE BAKING WAGES COUNCIL (NORTHERN IRELAND) WAGES REGULATION (AMENDMENT) (No. 6) ORDER, 1950, DATED 5TH JUNE, 1950, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER SECTION 10 OF THE WAGES COUNCILS ACT (NORTHERN IRELAND), 1945 (9 & 10 GEO. 6, CH. 21).

WHEREAS the Ministry of Labour and National Insurance (hereinafter referred to as "the Ministry") has received from the Baking Wages Council (Northern Ireland) wages regulation proposals for the further

amendment of the Baking Wages Council (Northern Ireland) Wages Regulation (No. 3) Order, 1949 (a) (hereinafter referred to as "Order N.I.Bk. (91) ") dated the 4th day of April, 1949 as amended by the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 3) Order, 1949 (b) dated the 13th day of June, 1949 and the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 3) Order, 1950 (c) dated the 3rd day of January, 1950; which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates ;

NOW, THEREFORE, the Ministry by virtue of section 10 of the Wages Councils Act (Northern Ireland), 1945, and of every other power in that behalf hereby makes the following Order :—
