

5. NOW THEREFORE the Authority in exercise of the powers conferred on them by sub-section (4) of section twenty-eight of the Act hereby adopt the following New General Scheme providing for the modification of the said General Scheme, that is to say —

#### NEW GENERAL SCHEME

The name of the Malone Place Hospital shall be inserted opposite the name of the South Belfast Hospital Management Committee in the said General Scheme and the South Belfast Hospital Management Committee shall manage and control the said Malone Place Hospital as from the first day of January one thousand nine hundred and fifty.

6. The General Scheme shall be read and shall operate as modified by this further new General Scheme.

#### Local Ambulance Services

ORDER, DATED 27TH SEPTEMBER, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION FORTY-ONE OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

1950. No. 166

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred upon it by section forty-one of the Health Services Act (Northern Ireland), 1948 (in this Order referred to as "the Act"), hereby orders as follows:—

1.—(1) This Order may be cited as the Health Services (Local Ambulance Services) Order (Northern Ireland), 1950.

(2) The Interpretation Act, 1921 shall apply for the purpose of the interpretation of this Order in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. Section forty-one of the Act shall cease to have effect as from the thirtieth day of September, One thousand, nine hundred and fifty.

**General Medical and Pharmaceutical Services**

REGULATIONS, DATED 1ST AUGUST, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

1950. No. 128

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by section twelve of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Health Services (General Medical and Pharmaceutical Services) (Amendment) Regulations (Northern Ireland), 1950, and shall be construed as one with the Health Services (General Medical and Pharmaceutical Services) Regulations (Northern Ireland), 1948 (a) (hereinafter referred to as the Principal Regulations); the Health Services (General Medical and Pharmaceutical Services) (Amendment) Regulations (Northern Ireland), 1948 (b) and the Health Services (General Medical and Pharmaceutical Services) (Amendment) Regulations (Northern Ireland), 1949 (c).

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. The following paragraph shall, for the removal of any doubt, be added to Regulation 28 of the Principal Regulations :—

“ The said Drug Tariff may be amended from time to time by the Ministry after consultation with such organisation or organisations as aforesaid ”.
