- 9. References. When applying for admission to training candidates must furnish the names and addresses of two persons to whom reference may be made by the Ministry as to the suitability of the candidate for admission to training. In the case of candidates in the Ordinary Entry category one of these persons must be the Principal of the school last attended by the candidate.
- 10. The Interpretation Act, 1921 (Northern Ireland), shall apply for the purpose of the interpretation of these Regulations as it applies for the purpose of the interpretation of an Act of the Parliament of Northern Ireland.

APPENDIX

- A. ORDINARY ENTRY CANDIDATES.
- (1) To be eligible for admission to training a candidate in the Ordinary Entry category must $\,$
 - (a) pass the Ministry's Grammar School Senior Certificate Examination in 1951, without compensation in English,
 - (b) pass the test in general suitability, and
 - (c) pass the test in medical fitness.
- (2) Subject to the conditions prescribed in (1) above, the order of merit in respect of each training college will be determined for men and women separately by the addition of the marks obtained in the Senior Certificate Examination in
 - (a) English; and
 - (b) any other five subjects of the examination (except subsidiary language subjects) not more than four of which may be Mathematical subjects.
- B. SPECIAL ENTRY CANDIDATES.

To be eligible for admission to training a candidate in the Special Entry category must pass the tests in general suitability and medical fitness in addition to satisfying the conditions laid down in Regulation 4 (b) of these Regulations.

REGULATIONS, DATED 12TH OCTOBER, 1950, MADE BY THE MINISTRY OF EDUCATION, UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Training College Teachers' (Salaries and Allowances) Amendment Regulations (Northern Ireland), 1950.
 - 2. These Regulations shall come into operation on the date hereof.
- 3. The existing Regulations hereby amended are the Training College Teachers' (Salaries and Allowances) Regulations (Northern Ireland), 1948, as amended by the Training College Teachers' (Salaries and Allowances) (Amendment) Regulations (Northern Ireland), 1948
- 4. Regulation 2 (d) of the existing Regulations shall be amended by the deletion of the words "and Larkfield Training College, Dunmurry, Belfast."
- 5. The proviso (2) to Regulation 8 of the existing Regulations shall be amended by the deletion of the date "1st April, 1948" and the substitution therefor of the date "1st April, 1955."

EMPLOYMENT AND TRAINING Payment of Travelling Expenses

REGULATIONS, DATED 22ND DECEMBER, 1950, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE EMPLOYMENT AND TRAINING ACT (NORTHERN IRELAND), 1950.

1950. No. 230

The Ministry of Labour and National Insurance, with the consent of the Ministry of Finance, in exercise of the powers conferred by subsection (3) of section 5 of the Employment and Training Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, hereby makes the following regulations:—

- 1.—(1) These regulations may be cited as the Employment and Training (Payment of Travelling Expenses) Regulations (Northern Ireland), 1950, and shall come into operation forthwith.
 - (2) In these regulations, unless the context otherwise requires—
 "the Act" means the Employment and Training Act (Northern Ireland), 1950;
 - "the Ministry" means the Ministry of Labour and National Insurance for Northern Ireland.
- (3) Reference in these regulations to any enactment shall, unless the context otherwise requires, be construed as a reference to that enactment as amended by or under any other enactment.
