REGULATIONS, DATED 25TH MAY, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER ARTICLE 4 (a) OF PART IV OF THE FIRST SCHEDULE OF THE HEALTH SERVICES ACT (NORTHERN IRELAND); 1948.

The Ministry of Health and Local Government for Northern Ireland, (in these Regulations referred to as "the Ministry") in exercise of the powers conferred upon it by Article 4 (a) of Part IV of the First Schedule of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Health Services (Payment of Fees) Regulations (Northern Ireland), 1950.

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. The Northern Ireland Hospitals Authority may, with the approval of the Ministry, pay to the Chairman of a Committee of the Authority fees not exceeding the sum of two hundred and fifty guineas in any period of twelve months.

REGULATIONS, DATED 31ST OCTOBER, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER ARTICLE 4 (a) OF PART IV OF THE FIRST SCHEDULE OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government for Northern Ireland in exercise of the powers conferred upon it by Article 4 (a) of Part IV of the First Schedule of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Health Services (Payment of Fees) (Amendment) Regulations (Northern Ireland), 1950.

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. In Regulation two of the Health Services (Payment of Fees) Regulations (Northern Ireland), 1950 (a) for the words "a Committee" there shall be substituted the words "the Distinction Awards Subcommittee."

### General Scheme : Modification

ORDER, DATED 1ST JANUARY, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION TWENTY-EIGHT OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

WHEREAS sub-section (4) of section twenty-eight of the Health Services Act (Northern Ireland), 1948, provides that the Northern Ireland Hospitals Authority (in this Order referred to as "the Authority") may from time to time, after consultation with the Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), adopt a new general scheme providing for the modification of the general scheme for the time being in force :

AND WHEREAS the Authority has adopted and submitted to the Ministry a new general scheme providing for the modification of the general schemes adopted by the Authority on the 13th day of May, 1948, the 9th day of November, 1948, and the first day of September, 1949, and approved (with modifications) by the Ministry by Orders dated the 31st day of May, 1948 (b), 31st day of December, 1948 (c), and 30th day of September, 1949 (d) :

AND WHEREAS the Ministry thinks fit to approve the said new general scheme ;
