- 4. The existing Regulations shall have effect as if for paragraph (2) (a) of Regulation 11 thereof there were substituted the following paragraph:—
  - "(2) (a) For a dinner supplied to a pupil the parent shall be charged an amount not exceeding by more than one penny the cost of the food supplied therein."

The Ministry of Education, with the approval of the Ministry of Finance, in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. These Regulations may be cited as The Parliamentary Grants (Local Education Authorities) Amending Regulations, 1950.
  - 2. These Regulations shall come into operation on the date hereof.
- 3. The existing Regulations hereby amended are The Parliamentary Grants (Local Education Authorities) Regulations, 1948.
- 4. The existing Regulations shall have effect as if for Regulation 7 thereof there were substituted therefor:—
  - "7. For the purpose of determining the amount of grant payable under Regulation 6 of these Regulations there shall be deducted from the expenditure specified therein any sums received by the local education authority from parents as payment for school meals, and any other receipts which in the opinion of the

Ministry should be taken into account in determining the appropriate net expenditure incurred by the authority."

REGULATIONS, DATED 8TH JUNE, 1950, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 AND 1950, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1950. No. 96

The Ministry of Education in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, as amended by Section 1 of the Education (Miscellaneous Provisions) Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

- 1. These Regulations may be cited as "The Parliamentary Grants (Local Education Authorities) Amending Regulations No. 2, 1950".
- 2. The existing Regulations hereby amended are The Parliamentary Grants (Local Education Authorities) Regulations, 1948, hereinafter referred to as "the principal Regulations".
- 3. The following clause is hereby added to paragraph (b) of Regulation 3 of the principal Regulations with effect as from 5th July, 1948.
  - "(v) the cost to the local education authority of employers' contributions payable under the National Insurance Acts (Northern Ireland), 1946, incurred before, but not after the 31st day of March, 1951, in respect of full-time teachers in county primary schools, county intermediate schools, county grammar schools, and in nursery schools, special schools and institutions of further education under the control of the local education authority."
- 4. Clause (i) of paragraph (a) of Regulation 4 of the principal Regulations is hereby revoked and the following clause substituted therefor:—
