In exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945 (a), (as extended by the Supplies and Services (Extended Purposes) Act, 1947 (b), and the Supplies and Services (Defence Purposes) Act, 1951 (c), and continued in force by the Supplies and Services (Continuance) Order, 1950 (d)) delegated to it by an Instrument of Delegation dated the 2nd day of July, 1946, made by the Board of Trade under the said Regulations, as having effect as aforesaid, and of all other powers it enabling, the Ministry of Commerce for Northern Ireland hereby orders as follows:—

- For Article 7 of the Utility Furniture (Marking and Supply) (No. 2) (Northern Ireland) Order, 1950, (e) as amended by the Utility Furniture (Marking and Supply) (Amendment) (Northern Ireland) Order, 1951 (f), there shall be substituted the following Article:
 - "7.—(1) A person may in the course of his business use utility goods, being cloth of a description specified in relation to the specification number 7585 in Schedule HT5 to the Household Textiles (Marking and Manufacturers' Prices) Order, 1951 (g), in the manufacture of furniture, being upholstered divans, to which he intends to apply the utility mark in accordance with a licence granted under paragraph (2) of Article 1 of this Order.
 - (2) A person may in the course of his business use utility goods, being cloth of a description specified in relation to —
 - (a) the specification number 110 in the Schedule to the Utility Woven Cloth (Wool and Animal Fibre) (Marking, Supply and Manufacturers' Prices) Order, 1950 (h) as amended from time to time (i), or
 - (b) one of the specification numbers (whether or not preceded by the letter "Z") included in Part I or Part 2 of the Schedule to the Utility Upholstery Cloth Order, 1951 (i),

in the manufacture of upholstered furniture to which he intends to apply the utility mark in accordance with a licence granted under paragraph (2) of Article 1 of this Order."
