Parliamentary Grants in Aid of Expenses of Local Education Authorities Amending Regulations

REGULATIONS, DATED 29TH JANUARY, 1951, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1950.

1951. No. 19

The Ministry of Education, with the approval of the Ministry of Finance, in pursuance of the powers vested in it by Sections 93, 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. These Regulations may be cited as "The Parliamentary Grants (Local Education Authorities) Amending Regulations No. 3, 1951."
- 2. These Regulations shall apply to grants payable in respect of the period from 1st August, 1950, to 31st March, 1951, in the financial year ending on the latter date and in respect of each succeeding financial year ending on 31st March.
- 3. The existing Regulations hereby amended are The Parliamentary Grants (Local Education Authorities) Regulations, 1948, hereinafter referred to as the "principal Regulations".
- 4. The principal Regulations shall have effect as if for the heading to Part III and Regulation 5 thereof there were substituted therefor the following:—
 - "(Grants payable to local education authorities in respect of the provision of milk, meals and other refreshment in schools and institutions providing further education)"
 - 5. In this Part of these Regulations, unless the contrary intention appears, the following expressions have the meanings hereby assigned to them, that is to say:—
 - " pupil" means a pupil in attendance at -
 - (a) any primary, intermediate or special school, or
 - (b) any county grammar school, or
 - (c) a full-time day course in an institution providing further education who has not attained the age of eighteen years.
 - "school meal" means a dinner as defined by Regulation 8 of the Milk and Meals Regulations (Northern Ireland), 1948.

5. Regulation 6 (b) of the principal Regulations shall be amended by the addition after the word "schools" of the following:—

" and institutions providing further education."

REGULATIONS, DATED 12TH APRIL, 1951, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 AND 1950, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, as amended by Section 1 of the Education (Miscellaneous Provisions) Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as The Parliamentary Grants (Local Education Authorities) Amending Regulations No. 4, 1951.
- (2) These Regulations shall apply to grants payable in respect of the financial year ending on 31st March, 1951, and each financial year ending on 31st March thereafter.
- 2. The existing Regulations hereby amended are the Parliamentary Grants (Local Education Authorities) Regulations, 1948, hereinafter referred to as "the principal Regulations".
- 3. The following sub-paragraph is hereby added to paragraph (b) of Regulation 3 of the principal Regulations
 - "(vi) the cost to the local education authorities of employers' contributions payable under any scheme of superannuation for teachers established by or under any enactment
