

3. The Milk and Meals Amending Regulations (Northern Ireland), 1950, are hereby revoked.

4. The existing Regulations hereby amended are the Milk and Meals Regulations (Northern Ireland), 1948.

5. The existing Regulations shall have effect as if for sub-paragraph (a) of paragraph (2) of Regulation 11 thereof there were substituted the following :—

“(2) (a) For a dinner supplied to a pupil the parent shall be charged an approved amount not exceeding the cost of the food supplied therein ; and ”

Primary Schools (General) (Amending)

REGULATIONS, DATED 24TH JULY, 1952, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1952.

1952. No. 129

The Ministry of Education (hereinafter referred to as “ the Ministry ”) in pursuance of the powers vested in it by Section 112 of the Education Act (Northern Ireland) 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Primary Schools (General) Amending Regulations (Northern Ireland) 1952.

(2) These Regulations shall come into operation on 1st August, 1952.

2. The Regulations hereby amended are the Primary Schools (General) Regulations (Northern Ireland) 1949, as amended by the Primary Schools (General) (Amending) Regulations (Northern Ireland) 1950, hereinafter referred to as “ the principal Regulations.”

3. The principal Regulations shall be amended by the addition to them of the following Regulations :—

“ 16A.—(1) Subject to the following provisions of this Regulation an attendance shall mean an attendance on any day under instruction, other than in religious education, for a period of not less than —

(a) 3 hours in the case of a pupil enrolled in a class composed mainly of pupils who, at the commencement of the school year, had not attained the age of 8 years ;

- (b) 4 hours in the case of a pupil enrolled in a class composed mainly of pupils who, at the commencement of the school year, had attained the age of 8 years but had not attained the age of 11 years and 6 months ;
- (c) 4½ hours in the case of a pupil enrolled in a class composed mainly of pupils who, at the commencement of the school year, had attained the age of 11 years and 6 months.
- (2) The attendance of a pupil under such instruction as aforesaid for not less than three hours may, on not more than one day (other than a Saturday) in any week, be regarded as an attendance if provision has been made on the approved time-table for organised games on that day.
- (3) In the case of a pupil to whom the provisions of sub-paragraph (b) or sub-paragraph (c) of paragraph (1) of this Regulation applies, an attendance shall be made in two sessions separated by a period of not less than half an hour.

Provided that the Ministry may approve the modification of this Regulation in the case of a pupil for whom educational instruction of a special nature is being provided.

16B. The minimum time constituting an attendance may include any time occupied by a pupil :—

- (a) in undergoing inspection or treatment under a scheme of School Medical Service ;
or
(b) in attending an examination ; or
(c) in any other manner approved by the Ministry."
