### Training Colleges: Salaries and Allowances Amending Regulations

REGULATIONS, DATED 11TH OCTOBER, 1954, MADE BY THE MINISTRY OF  
EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND),  
1947-1953, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Training College Teachers' (Salaries and Allowances) Amending Regulations (Northern Ireland), 1954.
2. The principal Regulations hereby amended are the Training College Teachers' (Salaries and Allowances) Regulations (Northern Ireland), 1951.
3. These Regulations shall have effect as from 1st April, 1954.
4. For Regulation 3 of the principal Regulations there shall be substituted the following:—

“3.—(1) Subject to the provisions of these Regulations the salary scales for full-time lecturers and senior lecturers employed in recognised training colleges shall be as follows:—

#### LECTURERS

MEN: From a minimum of £625 rising by annual increments of £25 to £900 and by a final increment of £15 to a maximum of £915 per annum.

WOMEN: From a minimum of £575 rising by annual increments of £25 to £800 and by a final increment of £15 to a maximum of £815 per annum.

#### SENIOR LECTURERS

MEN: From a minimum of £915 rising by annual increments of £25 to a maximum of £1,115 per annum.

WOMEN: From a minimum of £815 rising by annual increments of £25 to a maximum of £1,015 per annum.

(2) The scale salary payable to lecturers under paragraph (1) of this Regulation shall be increased by £50 in the case of a lecturer who possesses a first or second class honours degree of an approved university or a qualification which the Ministry regards as equivalent to such a degree."

### Electoral Registers (Publication)

ORDER IN COUNCIL, DATED 21ST APRIL, 1954, MADE UNDER SUB-SECTION (5) OF SECTION THIRTEEN OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946, AS AMENDED BY SECTION NINE OF THE ELECTORAL LAW AMENDMENT ACT (NORTHERN IRELAND), 1953.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND  
WAKEHURST

WHEREAS by sub-section (5) of section thirteen of the Elections and Franchise Act (Northern Ireland), 1946, as amended by section nine of the Electoral Law Amendment Act (Northern Ireland), 1953, it is provided that if under any law for the time being in force with respect to elections of members to serve in the Parliament of the United Kingdom annual registers of electors are required to be published for constituencies in Northern Ireland in each year on a day earlier than the first day of April but not earlier than the fifteenth day of February, the Governor of Northern Ireland may by Order in Council provide that the register prepared under this section shall in each publication year be published on such first-mentioned day and that the qualifying date shall be such day, not being less than five months earlier, as may be so provided:

AND WHEREAS by sub-sections (2) and (4) of section one of the Electoral Registers Act, 1949, as substituted therein by section one of the Electoral Registers Act, 1953, it is provided in effect that registers of parliamentary electors in Northern Ireland with respect to elections of members to serve in the Parliament of the United Kingdom shall be published not later than the fifteenth day of February in each year and that as regards Northern Ireland the fifteenth day of September in any year shall be the qualifying date for such a parliamentary election as aforesaid:
