Grammar School (Grant Conditions)

REGULATIONS, DATED 13TH APRIL, 1955, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1953, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

'The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, with the approval of the Ministry of Finance, hereby makes the following Regulations:—

• 1. These Regulations may be cited as the Grammar School (Grant Conditions) Amending Regulations, 1955.

2. The existing Regulations hereby amended are the Grammar School (Grant Conditions) Regulations, 1948(a).

3. For the purposes of reducing the school fees that would otherwise be payable in respect of pupils in the secondary department the Ministry may increase the rates of capitation grant specified in paragraph 4 of the Third Schedule to the existing Regulations by £1 3s. 0d. in respect of each pupil in the lower and upper divisions of a voluntary grammar school for the school year ending 31st July, 1955, and for each of the four succeeding school years: Provided that the amount of additional grant payable under the provisions of this Regulation shall not be subject to the adjustments referred to in paragraph 6 of the said Schedule.

EDUCATION

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Grammar School (Salaries and Allowances of Teachers) Amending Regulations, 1955.

(2) These Regulations shall take effect as from 1st October, 1955.

(3) In these Regulations "the principal Regulations" means the Grammar School (Salaries and Allowances of Teachers) Regulations, 1954(a), and "the relevant proportion" has the meaning assigned to it by Regulation 4.

(4) These Regulations shall be construed as one with the principal Regulations.

2. The principal Regulations shall have effect subject to the provisions of these Regulations.

3.—(1) The sum shown opposite to each year of service of the scales for women specified in Regulation 5 of the principal Regulations shall be augmented by the addition of the relevant proportion of the difference between the aforesaid sum and the sum shown opposite to the same year of service of the corresponding scale for men.

(2) The allowances specified for women teachers in subparagraphs (a), (b) and (c) of paragraph 2 of Regulation 9 of the principal Regulations shall be augmented by the addition of the relevant proportion of the difference between the allowance applicable to a man and to a woman teacher under the appropriate sub-paragraph of the said Regulation 9.

(3) The rate of salary specified in Regulation 10 of the principal Regulations as applicable to an unqualified woman teacher shall be augmented by the addition of the relevant proportion of the difference between the aforesaid rate and the rate of salary of an unqualified man teacher.

4. The relevant proportion for each period set out in column (i) below shall be the proportion shown opposite in column (ii)

Provided that where the amount of the addition includes a fraction of a pound the said fraction shall be ignored if under 10s. and reckoned as $\pounds 1$ 0s. 0d. if it is 10s. or over.

5. From the 1st April, 1961, the salaries and allowances prescribed for men shall apply equally to women.

6. Paragraph 3 of Regulation 9 of the principal Regulations shall have effect as if for the words "and in the case of a man a further annual increment of £25, to the maximum of Scale V" wheresoever they occur there were substituted "and a final annual increment to the maximum of Scale V".

Voluntary Grammar Schools-Milk and Meals Grants

REGULATIONS DATED 31ST MARCH, 1955, MADE BY THE MINISTRY OF EDUCATION WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 43, 104 and 112 of the Education Act (Northern Ireland), 1947, (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following Regulations:—

1.-(1) These Regulations may be cited as the Voluntary Grammar Schools Milk and Meals Grants Regulations (Northern Ireland), 1955.

(2) These Regulations shall come into operation on 1st April, 1955.

(3) The Voluntary Grammar Schools Meals Grants Regulations (Northern Ireland), 1953(a), are hereby revoked.

2.—In these Regulations the following expressions have the meanings, hereby assigned to them, that is to say—
