## Parliamentary Grants in Aid of Expenses of Local Education Authorities

REGULATIONS DATED 31st March, 1955, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 to 1953.

1955. No. 50

The Ministry of Education, with the approval of the Ministry of Finance, in pursuance of the powers vested in it by Sections 93, 104 and 112 of the Education Act (Northern Ireland), 1947 and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. These Regulations may be cited as "The Parliamentary Grants (Local Education Authorities) Amending Regulations, No. 6, 1955".
- 2. These Regulations shall come into operation from 1st April, 1955.
- 3. The existing Regulations hereby amended are The Parliamentary Grants (Local Education Authorities) Regulations, 1948.(a).
- 4. For Regulation 5 of the existing Regulation there shall be substituted the following:—
  - "5. In this Part the following expressions have the meanings hereby assigned to them, that is to say:—
    - "pupil" means—
      - (a) a pupil in attendance at any primary, intermediate, special or independent school or any county grammar school; or
      - (b) a pupil in attendance at a full-time day course in an institution providing further education who has not attained the age of eighteen years; or
      - (c) for the purpose of grant in respect of expenditure on the provision of milk, a pupil in attendance at a voluntary grammar school for the pupils of which milk is supplied by the local education authority.

"school meal" means a dinner as defined in the Milk and Meals Regulations (Northern Ireland), 1955".

## Primary Schools: Salaries and Allowances

REGULATIONS DATED 21ST SEPTEMBER, 1955, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1947 TO 1953, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Primary Schools (Salaries and Allowances) Amending Regulations (Northern Ireland), 1955.
- (2) These Regulations shall come into operation on the 1st day of October, 1955.

(3) In these Regulations the expression

- "the principal Regulations" means the Primary Schools (Salaries and Allowances) Regulations (Northern Ireland), 1954(a);
- "the relevant proportion" has the meaning assigned to it by Regulation 4.
- (4) These Regulations amend and shall be construed as one with the principal Regulations.
- 2.—(1) The sum shown opposite to each year of service of each of the scales for women teachers specified in Regulation 4 of the principal Regulations shall be augmented by the addition of the relevant proportion of the difference between the aforesaid sum and the sum shown opposite to the same year of service of the corresponding scale for men.
- (2) Each of the allowances specified for women teachers in sub-paragraphs (a), (b) and (c) of paragraph (2) of Regulation 11 of the principal Regulations shall be augmented by the addition of the relevant proportion of the difference between the allowance applicable to a man and the allowance applicable to a woman under the appropriate sub-paragraph of the said Regulation 11.
