- (11) Applications to stay concurrent suits while the judgment or order is in prosecution in Chambers:
- (12) Applications to appoint new trustees of charities, and for such vesting and other consequential orders as the Court has jurisdiction to make upon petition in such cases, and all applications under 52 Geo. III, c. 101:
- (13) Such other matters as the Judge may think fit to dispose of at Chambers."

2. In Order LXXVII (which relates, inter alia, to proceedings under the Trustee Act, 1893) para. (d) of Rule 9 shall be amended by deleting the words "in any case where the money or securities in Court does or do not exceed $\pounds 500$ or $\pounds 500$ nominal value."

The Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") in pursuance of the powers conferred upon it by sub-section (1) of Section 126 and subsection (2) of Section 134 of the Children and Young Persons Act (Northern Ireland), 1950, hereby makes the following Regulations:—

1. The contributions to be made under sub-section (1) of Section 126 of the Children and Young Persons Act (Northern Ireland), 1950, by the local authority named in a training school order to the expenses of the managers of a training school throughout any time in the financial year 1956-57 during which the person to whom the order relates is under the care of the said managers and not out on licence or under supervision shall be at the rate of sixty-seven shillings and one penny a week.

2. These Regulations may be cited as the Training Schools (Contributions by Local Authorities) Regulations (Northern Ireland), 1956, and shall come into operation on the 1st day of April, 1956.

The Ministry of Finance by virtue of powers conferred upon it by sub-section (1) of Section 15 of the Exchequer and Financial Provisions Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, hereby makes the following Regulations:-

1. On and after 23rd April, 1956, the following shall be substituted for "(d)" of Article 1 of the Ulster Savings Certificates (Eighth Issue) (Amendment) Regulations, 1955(a):
