**Constitution and Amendment of Local Electoral Areas in  
County Antrim under the Newtownabbey Urban District  
Act (Northern Ireland), 1957**

ORDER, DATED 14TH NOVEMBER, 1957, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION FORTY OF THE NEWTOWNABBEY URBAN DISTRICT ACT (NORTHERN IRELAND), 1957.

Whereas by virtue of the Newtownabbey Urban District Act (Northern Ireland), 1957 (in this Order referred to as "the Act") the Rural District of Belfast will on the 1st day of April, 1958, be abolished and a new Urban District called the Urban District of Newtownabbey (in this Order referred to as "the Urban District") will be formed and portions of the Rural District of Belfast will be transferred to the Rural Districts of Antrim, Larne and Lisburn respectively:

And Whereas it is necessary to make an Order constituting and amending the local electoral areas in consequence of the passing of the Act:

Now, Therefore, the Ministry of Health and Local Government (in this Order referred to as "the Ministry"), in exercise of the powers conferred upon it by section forty of the Act and of all

other powers enabling it in that behalf, hereby makes the following Order:

1. This Order may be cited as the Newtownabbey Urban District (Electoral Areas) Order (Northern Ireland), 1957.

*Wards—Newtownabbey Urban District*

2.—(1) The Urban District shall be divided into the Seven Wards described in the Schedule to this Order.

(2) The number of councillors which shall be elected for each Ward shall be Three.

*District Electoral Divisions*

RURAL DISTRICT OF LISBURN

3. The area transferred to the Rural District of Lisburn and described in the Third Schedule to the Act shall be a district electoral division within the Rural District of Lisburn and shall be named the District Electoral Division of Ballygomartin.

RURAL DISTRICT OF LARNE

4. The area transferred to the Rural District of Larné and described in the Fourth Schedule to the Act shall form part of the District Electoral Division of Carrickfergus Rural.

RURAL DISTRICT OF ANTRIM

5. The area transferred to the Rural District of Antrim and described in the Second Schedule to the Act shall be a district electoral division within the Rural District of Antrim and shall be named the District Electoral Division of Ballyduff.

*County Electoral Divisions*

6.—(1) The Urban District shall be a County Electoral Division named the Newtownabbey County Electoral Division within the administrative County of Antrim.

(2) The number of councillors to be elected for the County Electoral Division of Newtownabbey shall be Two.

(3) The District Electoral Division of Ballygomartin referred to in Article 3 of this Order shall be a County Electoral Division named the Ballygomartin County Electoral Division within the administrative County of Antrim.

(4) The District Electoral Division of Carrickfergus Rural as amended by Article 4 of this Order shall form part of the County Electoral Division of Carrickfergus within the administrative County of Antrim.

(5) The District Electoral Division of Ballyduff referred to in Article 5 of this Order shall form part of the County Electoral Division of Crumlin within the administrative County of Antrim.

## SCHEDULE

**Name and Boundaries of Wards of Newtownabbey Urban District****CARNMONEY WARD**

The boundary of Carnmoney Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at a point on the centre of Station Road, Monkstown, thence in a westerly direction along the said Urban District boundary to the junction of Manse Road, Ballyduff, and Carnmoney Road, thence in a southerly direction along the centre of Carnmoney Road and its prolongation to the centre of Antrim Road, thence in a south-easterly direction along the centre of Antrim Road to its junction with Whitewell Road, thence in a south-easterly direction along the centre of Whitewell Road to its junction with Tory Lane, thence in a north-easterly, northerly, easterly, northerly and north-easterly direction along the centre of Tory Lane to a point on the centre of Church Road, thence in a south-easterly direction along the centre of Church Road to its junction with Old Irish Highway, thence in an easterly direction along the centre of Old Irish Highway to its junction with Doagh Road, thence in a northerly direction along the centre of Doagh Road to its junction with Station Road, Monkstown, thence along the centre of Station Road, Monkstown, to the point first mentioned.

**CAVEHILL WARD**

The boundary of Cavehill Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at a point on the centre of Hightown Road, thence in a generally southerly and easterly direction along the said Urban District boundary to a point on the centre of Whitewell Road, thence in a north-westerly direction along the centre of Whitewell Road to its junction with Antrim Road, thence in a north-westerly direction along the centre of Antrim Road to its junction with Hightown Road, thence in a south-westerly direction along the centre of Hightown Road to the point first mentioned.

**GLENGORMLEY WARD**

The boundary of Glengormley Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at the junction of Manse Road, Ballyduff and Carnmoney Road, thence in a southerly direction along the centre of Carnmoney Road and its prolongation to the centre of Antrim Road, thence in a north-westerly direction along the centre of Antrim Road to its junction with Hightown Road, thence in a south-westerly direction along the centre of Hightown Road to the Newtownabbey Urban District boundary, thence in a generally northerly direction along the said Urban District boundary to the point first mentioned.

**JORDANSTOWN WARD**

The boundary of Jordanstown Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at the intersection of Silver Stream by High Water Mark, thence following the said Urban District boundary in a north-westerly and westerly direction to a

point on the centre of Station Road, Monkstown, thence in a southerly direction along the centre of Station Road, Monkstown, to its junction with Doagh Road, thence along the centre of Doagh Road in a south-easterly direction for approximately 973 yards, thence along the centre of the road running eastwards from this point and its prolongation to the eastern fence of the U.T.A. Railway at or near Dillon's Avenue, thence in a northerly direction along the eastern face of the aforementioned railway fence and its prolongation to a point on the centre of Glenville Road, thence along the centre of Glenville Road in a south-easterly direction to a point on the centre of Shore Road, thence in a north-easterly direction along the centre of Shore Road to a point at the centre of Three-Mile-Water, thence along the centre of the stream to its inter-section by Newtownabbey Urban District boundary at High Water Mark, thence in a north-easterly direction along the said Urban District boundary to the point first mentioned.

#### WHITEABBEY WARD

The boundary of Whiteabbey Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at the junction of High Water Mark and the boundary between the townlands of Whiteabbey and Whitehouse, thence in a westerly direction along this last boundary to a point on the centre of Shore Road, thence in a southerly direction along the centre of Shore Road to its junction with Doagh Road, thence in a north-westerly direction along the centre of Doagh Road to a point approximately 325 yards north of Cloughfern Corner, thence along the centre of the road running eastwards from this point and its prolongation to the eastern fence of the U.T.A. Railway at or near Dillon's Avenue, thence in a northerly direction along the eastern face of the aforementioned railway fence and its prolongation to a point on the centre of Glenville Road, thence along the centre of Glenville Road in a south-easterly direction to a point on the centre of Shore Road, thence in a north-easterly direction along the centre of Shore Road to a point at the centre of Three-Mile-Water, thence along the centre of the stream to its inter-section by Newtownabbey Urban District boundary at High Water Mark, thence in a southerly direction along the said Urban District boundary to the point first mentioned.

#### WHITEHOUSE WARD

The boundary of Whitehouse Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at the junction of High Water Mark and the boundary between the townlands of Whitehouse and Whiteabbey, thence in a westerly direction along this last boundary to a point on the centre of Shore Road, thence in a southerly direction along the centre of Shore Road to its junction with Doagh Road, thence in a north-westerly direction along the centre of Doagh Road to its junction with Old Irish Highway, thence in a westerly direction along the centre of Old Irish Highway to its junction with Church Road, thence in a south-easterly direction along the centre of Church Road for approximately 1313 yards to a point at the centre of Glas-na-Cradan, thence in an easterly direction along the centre of the said stream to its junction with the Newtownabbey Urban District boundary at High Water Mark, thence in a northerly direction along the said Urban District boundary to the point first mentioned.

## WHITEWELL WARD

The boundary of Whitewell Ward is a line drawn as follows:—

Commencing on the Newtownabbey Urban District boundary at the intersection of the Belfast County Borough boundary by High Water Mark, thence in a westerly direction along the Newtownabbey Urban District boundary to the centre of Whitewell Road, thence in a north-westerly direction along the centre of Whitewell Road to its junction with Tory Lane, thence in a north-easterly, northerly, easterly, northerly and north-easterly direction along Tory Lane to a point on the centre of Church Road, thence in a south-easterly direction along the centre of Church Road for approximately 1320 yards to a point at the centre of Glas-na-Cradan, thence in an easterly direction along the centre of the said stream to its junction with the Newtownabbey Urban District boundary at High Water Mark, thence in a southerly direction along the said Urban District boundary to the point first mentioned.

NOTE: Where in these descriptions a line is referred to as drawn along the centre of a road, it is intended that the description shall mean a line drawn along the centre of the carriageway.

### Qualifications of Engineers and Surveyors

REGULATIONS, DATED 1ST AUGUST, 1957, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION EIGHTEEN OF THE LOCAL GOVERNMENT ACT (NORTHERN IRELAND), 1934.

The Ministry of Health and Local Government (hereinafter referred to as "the Ministry"), in exercise of the powers vested in it by Section eighteen of the Local Government Act (Northern Ireland), 1934, and of every other power enabling it in that behalf, hereby makes the following Regulations, that is to say:—

1.—(1) These Regulations may be cited as the Local Authorities (Engineers and Surveyors) Regulations, (Northern Ireland), 1957.

(2) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them:—

"local authority" means the council of a county or other borough, or urban or rural district or any committee of, or joint committee or joint board partly appointed by, such council;

"surveyor" or "engineer" means the officer (by whatever name called) who is responsible to the local authority for the carrying out of its normal surveying or engineering functions, and whose ordinary description is indicated in the Schedule to these Regulations.

2. A person shall not be qualified to be appointed as surveyor or engineer of a local authority unless:

(a) he possesses the qualifications set forth in the Schedule to these Regulations in relation to such office;
