- (4) For the purposes of this Regulation the estimated cost of making good damage shall be the cost as estimated by or agreed by the Ministry.
- 10. These Regulations shall in their application to schools vested in the Ministry have effect subject to the following modifications:—
  - (a) applications for grant shall be made by the manager of the school;
  - (b) for Regulation 6 the following Regulation shall be substituted:—
    - "6. A grant shall not be paid under these Regulations unless the manager of the school provides or undertakes to provide such additional sum as will when added to the grant be sufficient in the opinion of the Ministry to meet the total cost of the works proposed to be carried out";
  - (c) in paragraph (1) of Regulation 7 and in Regulation 8 any reference to the applicants shall be deemed to be a reference to the manager of the school.

- 2.—(1) These Regulations may be cited as the Electricity Board for Northern Ireland Borrowing (Amendment) Regulations, 1957, and shall come into force on the thirtieth day of April, One Thousand Nine Hundred and Fifty-seven.
- (2) These Regulations shall be construed as one with the Electricity Board for Northern Ireland Borrowing Regulations, 1931, the Electricity Board for Northern Ireland Borrowing (Amendment) Regulations, 1935(b), and the Electricity Board for Northern Ireland Borrowing (Amendment) Regulations, 1939(c), and those Regulations and these Regulations may be cited together as the Electricity Board for Northern Ireland Borrowing Regulations, 1931 to 1957.
