The Ministry of Home Affairs in exercise of the powers conferred on it by sub-section (4) of section twenty-three of the Road Traffic Act (Northern Ireland), 1955 (a), and of all other powers enabling it in that behalf, hereby orders and directs as follows:—

1. The directions contained in the Roads (Speed Limit) Order (Northern Ireland), 1956(a), relative to the lengths of road specified in the First Schedule to this Order are hereby revoked.
2. Each of the lengths of road specified in the Second Schedule shall be a restricted road for the purposes of the said section twenty-three.
3. Each of the lengths of road specified in the Third Schedule shall not be a restricted road for the purposes of the said section twenty-three.
4. This Order shall come into operation on 2nd February, 1959, and may be cited as the Roads (Speed Limit) (No. 2) Order (Northern Ireland), 1958.

ROAD VEHICLES

REGULATIONS, DATED 22ND DAY OF SEPTEMBER, 1958, MADE BY THE
MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER
SECTION 8 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT
(NORTHERN IRELAND), 1929.

The Ministry of Home Affairs, in exercise of the powers vested in it by Section 8 of the Motor Vehicles and Road Traffic Act (Northern Ireland), 1929, and of all powers thereunto enabling it, hereby makes the following Regulations, that is to say:—

1. These Regulations may be cited as the Road Vehicles (Gallows Hill, Dunluce, Co. Antrim) Regulations, 1958.
2. A person shall not, except by the express direction or permission of a member of the Royal Ulster Constabulary, drive or propel a vehicle of any kind whatsoever in the portion of road in County Antrim specified in the schedule to these Regulations except in the direction prescribed in relation to the road in the schedule.
