REGULATIONS, DATED 8TH MAY, 1958, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION 18 OF THE LOCAL GOVERNMENT ACT (NORTHERN IRELAND), 1934.

The Ministry of Health and Local Government (hereinafter referred to as "the Ministry") in exercise of the powers vested in it by section eighteen of the Local Government Act (Northern Ireland), 1934, and of every other power enabling it in that behalf, hereby makes the following Regulations, that is to say:—

1. These Regulations may be cited as the Belfast County Borough Council (City Architect's Qualifications) Regulations (Northern Ireland), 1958.

2. A person shall not be qualified to be appointed to the office of City Architect of the City and County Borough of Belfast unless:

- (a) he is a Fellow or Associate of the Royal Institute of British Architects;
 - (b) he has had wide and suitable experience extending over a period of not less than ten years in the practice of his profession;

- (c) he produces satisfactory evidence that his health and character are good;
- (d) he is a natural born British subject and is the son of a father also a natural born British subject;
- (e) he has, during the whole of the period of five years ending on the date of his appointment, been resident in the United Kingdom.

3. The Ministry may from time to time assent to any departure from the provisions of these Regulations, if, in its opinion, the adoption of such a course is desirable.

BETTING AND LOTTERIES ACT (NORTHERN IRELAND), 1957

ORDER, DATED 29TH DAY OF JANUARY, 1958, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION THIRTY-SIX OF THE BETTING AND LOTTERIES ACT (NORTHERN IRELAND), 1957.

I, The Right Honourable W. W. B. Topping, Q.C., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section thirty-six of the Betting and Lotteries Act (Northern Ireland), 1957, and of all other powers enabling me in that behalf, do hereby order as follows:—

1. The provisions of the said Act specified in the First Schedule hereto (which relate to matters specified in the second column of the said Schedule) shall come into operation as from the date hereof and the provisions of the said Act specified in the Second Schedule hereto shall come into operation on the first day of April, 1958. Paragraph (j) of sub-section (1) of Section seven shall not, however, come into operation until the first day of April, 1959.

2. This Order may be cited as the Betting and Lotteries Act (Northern Ireland), 1957 (Date of Commencement) Order, 1958.
