## Benefit

REGULATIONS, DATED 29TH MAY, 1959, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NORTHERN IRELAND), 1946.

The Industrial Injuries Joint Authority, in exercise of powers conferred by section 30(1) of the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946(a), and of all other powers enabling them in that behalf, hereby make the following regulations:

## Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Benefit) Amendment Regulations (Northern Ireland), 1959, shall be read as one with the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland), 1948(b) (hereinafter referred to as "the principal regulations"), and shall come into operation on the 1st June, 1959.

## Amendment of regulation 29 of the principal regulations

2. Paragraph (2) of regulation 29 of the principal regulations (which paragraph specifies the personal benefits by reference to which dependency benefit under the Act is to be adjusted) shall be amended by substituting for sub-paragraphs (c) and (d) thereof the following sub-paragraph:

"(c) any personal benefit by way of unemployability supplement or any personal death benefit by way of pension or allowance (not being a grant payable by reason of the beneficiary being in receipt of a pension and being over seventy years of age or a pension or allowance calculated by reference to the necessities of the beneficiary), under any Personal Injuries Scheme or Service Pensions Instrument or any 1914-1918 War Injuries Scheme; and".
