## National Insurance—Modification of Teachers Superannuation Acts (Northern Ireland)

REGULATIONS, DATED 30TH DAY OF DECEMBER, 1960, MADE BY THE MINISTRY of Education under sub-section (4) of Section 66 of the National Insurance Act (Northern Ireland), 1946, (as extended by Section 14 OF THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1959), SECTION 23 OF THE TEACHERS (SUPERANNUATION) ACT (NORTHERN IRELAND), 1950, AND SECTION 25 OF THE TEACHERS (SUPERANNUATION) (AMENDMENT) ACT (Northern Ireland), 1956, with the approval of the Ministry of FINANCE.

The Ministry of Education in exercise of the powers conferred on it by sub-section (4) of Section 66 of the National Insurance Act (Northern Ireland), 1946(a) (as extended by Section 14 of the National Insurance Act (Northern Ireland), 1959(b)), Section 23 of the Teachers (Superannuation) Act (Northern Ireland), 1950(c), as applied by the Ministries (Transfer of Functions) (Teachers Superannuation) Order, 1951(d), Section 25 of the Teachers (Superannuation) (Amendment) Act (Northern Ireland), 1956(e), and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following regulations:—

- 1. These regulations may be cited as the National Insurance (Modification of Teachers Superannuation Acts) Regulations (Northern Ireland), 1960, and shall come into operation on the third day of April, 1961.
  - 2. In these regulations—
  - "the Act of 1950" means the Teachers (Superannuation) Act (Northern Ireland), 1950;
  - "the Act of 1956" means the Teachers (Superannuation) (Amendment) Act (Northern Ireland), 1956; and
  - "the Act of 1959" means the National Insurance Act (Northern Ireland), 1959.

- 3. The provisions of Section 10 of the Act of 1950 (which provides for the return of contributions) shall have effect, subject to the following modifications:—
  - (a) when computing the balance of contributions of a teacher, in respect of whom a payment in lieu of contributions has been made under the Act of 1959, the amount recoverable under Section 9 of that Act shall be deemed to have been deducted from his contributions on the day on which, disregarding any special arrangements of the kind referred to in paragraph (6) of regulation 18 of the National Insurance (Non-participation—Assurance of Equivalent Pension Benefits) Regulations (Northern Ireland), 1960(a), the payment in lieu of contributions became due; and
  - (b) when an amount equal to half of a payment in lieu of contributions made under the Act of 1959 has been deducted from the contributions repaid to a teacher and that teacher subsequently repays to the Ministry the sum so repaid to him, he shall not be treated as if no repayment had been made to him, but the period in respect of which the contributions were repaid shall be reckoned as contributory or recognised service.
- 4. The provisions of Section 20 of the Act of 1950 (which provides for refusal or reduction of pensions) shall be applied subject to the provision that no refusal or reduction of an annual superannuation allowance shall be made in pursuance of that section which would result in a teacher receiving, in respect of contributory service after the second day of April, 1961, which is non-participating employment, an amount less than the graduated retirement benefit which, when expressed as a yearly rate, would be payable to him under the Act of 1959 in return for an amount of graduated contributions equal to one such contribution paid in each week of the period of such service in respect of a weekly payment of remuneration of fifteen pounds.
- 5. The expression "superannuation expenditure" in sub-section (5) of Section 2 of the Act of 1956 (which provides that superannuation expenditure shall be charged against the Teachers Superannuation Account) shall be construed as including any expenditure in respect of payments in lieu of contributions by the Ministry to the Northern Ireland National Insurance Fund by virtue of Regulation 3 of the National Insurance (Non-participation—Teachers Superannuation) Regulations (Northern Ireland), 1960(b).
