EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order, which comes into operation on 20th May, 1960, amends the Laundry Wages Council (Northern Ireland) Wages Regulation Order, 1956 (Order N.I.L (53)) by increasing the statutory minimum remuneration fixed by that Order.

The Laundry Wages Council (Northern Ireland) Wages Regulation (Amendment) Order, 1958 (Order N.I.L. (58)) is revoked.

Registration of County Court Proceedings as Lites Pendentes

REGULATIONS, DATED 13TH MAY, 1960, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 35 OF THE REGISTRY OF DEEDS (IRELAND) ACT, 1832(a), AS APPLIED BY SECTION 56 OF THE COUNTY COURTS ACT (NORTHERN IRELAND), 1959(b).

In pursuance of Section 35 of the Registry of Deeds (Ireland) Act, 1832(a), as applied by Section 56 of the County Courts Act (Northern Ireland), 1959(b), the Ministry of Finance hereby makes the following Regulations:

Citation

1. These Regulations may be cited as the Registry of Deeds (Registration of County Court Proceedings as Lites Pendentes) Regulations (Northern Ireland), 1960.

Registration

2. Any proceedings in the County Court to affect unregistered land may be registered in the Registry of Deeds as a lis pendens by the lodgment of a memorial in the form prescribed in Part I of the Schedule.

Vacation of Registration

3. Any such registration may be vacated by the lodgment of a certificate in the form prescribed in Part II of the Schedule. Upon receipt of such certificate the Registrar shall make or cause to be made in the records of the Registry a memorandum in accordance with the terms of such certificate and thereafter this memorandum shall be recorded on any certificate of search on which reference to the corresponding memorial under Regulation 2 shall appear.

Certification

4. A memorial or certificate for the purpose of these Regulations shall be certified by the Clerk of the Crown and Peace for the Court in which the said proceedings are entered.

Fees

5. The fee payable on a memorial shall be as prescribed in sub-section (1) of Section 4 of the Registration of Deeds (Amendment) Act (Northern Ireland), 1957(a). A fee of five shillings shall be payable upon any certificate lodged under Regulation 4.

Paper .

6. The paper to be used for memorials under these Regulations shall be as prescribed in paragraph (1) of Regulation 1 of the Registration of Deeds (Nature of Paper) Regulations (Northern Ireland), 1957(b).
