EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations increase the weekly sums prescribed for the purpose of computing the requirements, other than rent, of applicants for assistance under the National Assistance Act (Northern Ireland), 1948. They increase the prescribed weekly sum for a married couple from 90s. to 95s. 6d. and for a single householder from 53s. 6d. to 57s. 6d. Proportionate increases have been made in the case of other classes of applicants.

Requirements

REGULATIONS, DATED 30TH JULY, 1962, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, WITH THE CONSENT OF THE MINISTRY OF FINANCE, UNDER THE NATIONAL ASSISTANCE ACT (NORTHERN IRELAND), 1948.

The Ministry of Labour and National Insurance in exercise of powers conferred by sections 9(7) and 32(1) of the National Assistance Act (Northern Ireland), 1948(a), and of all other powers enabling it in that behalf, with the consent of the Ministry of Finance, hereby makes the following regulations:

Citation, interpretation and commencement

1.—(1) These regulations may be cited as the National Assistance (Requirements) Regulations (Northern Ireland), 1962, and shall come into operation on the 1st August, 1962.

(2) In these regulations—

"the Act" means the National Assistance Act (Northern Ireland), 1948.

Requirements in respect of dental services

2.—(1) There shall be included in the meaning assigned to the expression "requirements" by sub-section (1) of section 32 of the Act any dental services, not being dental services provided under the Health Services Act (Northern Ireland), 1948(a), which, if they were so provided, would be services in respect of which charges are for the time being authorised by regulations made under section seventy-six of that Act.

(2) Sub-sections (2) and (4) of section 9 of the Act (which sub-sections provide for disqualification for assistance if the applicant or the applicant's husband is engaged in full time remunerative work) shall not apply in relation to requirements for the dental services mentioned in paragraph (1).
