Construction (Lifting Operations)—Reports

ORDER, DATED 28TH JUNE 1963, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE CONSTRUCTION (LIFTING OPERATIONS) REGULATIONS (NORTHERN IRELAND) 1963.

The Ministry of Labour and National Insurance for Northern Ireland in pursuance of Regulations 10(1) and (2), 19(4), 30(1), (2) and (3) and 46(1) of the Construction (Lifting Operations) Regulations (Northern Ireland) 1963(a) (hereafter in this Order referred to as "the Regulations") hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Construction (Lifting Operations) Reports Order (Northern Ireland) 1963, and shall come into operation on the 2nd day of September 1963.

Lifting appliances

2. A report of the results of every inspection—

- (a) made in pursuance of sub-paragraph (c) of paragraph (1) or paragraph (2) of Regulation 10 of the Regulations of a lifting appliance and every part thereof including all working gear and all other plant or equipment used for anchoring or fixing such appliance; or
- (b) made in pursuance of paragraphs (1) or (2) of Regulation 30 of the Regulations of an automatic safe load indicator of a kind referred to in that Regulation,

shall be made in the form set out in Part I of the Schedule to this Order and shall contain the particulars therein specified.

Cranes

3. A report of every test and the results thereof carried out in pursuance of paragraph (4) of Regulation 19 of the Regulations of the security of the anchorage, or the adequacy of the ballasting, of a crane shall be made in the form set out in Part II of the Schedule to this Order and shall contain the particulars therein specified.

Automatic safe load indicators

4. A report of the results of every test carried out in pursuance of paragraphs (1) or (2) of Regulation 30 of the Regulations of an automatic safe load indicator of a kind referred to in the said Regulation 30 shall be made in the form set out in Part III of the Schedule to this Order and shall contain the particulars therein specified.

Hoists

5. A report of the results of every test and thorough examination made in pursuance of sub-paragraph (b) of paragraph (1) of Regulation 46 of the Regulations of a hoist used for carrying persons shall be made in the form

set out in Part IV of the Schedule to this Order and shall contain the particulars therein specified.

EXPLANATORY NOTE

(This Note is not part of the Order, but is intended to indicate its general purport.)

This Order prescribes the forms of reports-

(a) of inspections of lifting appliances and automatic safe load indicators;

(b) of tests of cranes and automatic safe load indicators; and

(c) of tests and examinations of hoists used for carrying persons,

which are required by the Construction (Lifting Operations) Regulations (Northern Ireland) 1963.

DISEASES OF ANIMALS

Brucellosis

ORDER, DATED 4TH JULY, 1963, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTIONS 10, 12 AND 53 OF THE DISEASES OF ANIMALS ACT (NORTHERN IRELAND) 1958(a).

The Ministry of Agriculture in exercise of the powers conferred on it by Sections ten, twelve and fifty-three of the Diseases of Animals Act (Northern Ireland) 1958, and of every other power enabling it in that behalf hereby makes the following Order: —

Citation and Commencement

1. This Order may be cited as the Brucellosis Control (Amendment) Order (Northern Ireland) 1963, and, save as is provided in Article 3, shall come into operation on the 5th day of July 1963.

Amendment of Principal Order

2. The Brucellosis Control Order (Northern Ireland) 1962(b) (hereinafter referred to as the "Principal Order") shall be amended as follows: —

(1) At the end of Article 2 there shall be added the following definition :---

"'maiden heifer' means a female animal which is not and has not been pregnant."

(2) For sub-paragraph (b) of paragraph (3) of Article 10 there shall be substituted the following: --

"(b) the owner shall not move or cause or allow to be moved off his premises any animal in calf, any female animal aged 18 months or over, or any bull aged one year or over, except under and in accordance with the conditions of a licence issued by the Ministry:—
