DESTRUCTIVE INSECTS AND PESTS

Importation and Planting of Potatoes

ORDER, DATED 28TH MAY, 1964, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DESTRUCTIVE INSECTS AND PESTS ACTS (NORTHERN IRELAND) 1877 to 1934.

The Ministry of Agriculture in exercise of the powers conferred on it by the Destructive Insects and Pests Acts (Northern Ireland) 1877 to 1934(a), and of every other power enabling it in that behalf hereby makes the following Order:-

Citation and Commencement

1. This Order may be cited as the Importation and Planting of Potatoes Order (Northern Ireland) 1964, and shall come into operation on the 1st day of June, 1964.

Revocation

2. The Potatoes Importation (Ireland) Order 1920(b), the Foreign Seed Potatoes (Northern Ireland) Order 1925(c), the Potatoes Importation (Northern Ireland) Order 1931(d) and the Importation of Potatoes (Northern Ireland) Order of 1940(e) are hereby revoked.

Amendment of the Importation of Plants (Northern Ireland) Order 1955(f)

3. The Importation of Plants (Northern Ireland) Order 1955 shall cease to apply to potatoes and that Order shall be amended in accordance with the amendments set out in the Fifth Schedule to this Order.

Interpretation

4.—(1) In this Order,

"inspector" means an officer of the Ministry of Agriculture authorised for the purposes of this Order;

- "consignment" includes soil, packing materials, cases and containers;
- "importer" includes any person who, whether as owner, consignor or consignee, agent or broker is in possession of or in any wise entitled to the custody or control of the potatoes;
- "landing" in relation to the importation of potatoes means landing potatoes from a ship, vessel, aircraft or vehicle or otherwise introducing potatoes into Northern Ireland;
- "Ministry" means the Ministry of Agriculture;
- "potato" means the tuber or any part of the plant, except true seed, of Solanum tuberosum L. and of every other tuber-forming species of Solanum;
- "new potatoes" are potatoes which have been dug immature for marketing without delay, the skins of which can be removed by rubbing with the fingers or show evidence of natural skinning at the time of importation; "premises" includes any vehicle, vessel or aircraft;
- "unhealthy" means carrying or affected with any insect, fungus, pest, bacterium or other vegetable or animal organism destructive to agricultural or horticultural crops or to trees or bushes or with any agent causative of a transmissible crop disease.
- (2) The Interpretation Act (Northern Ireland) 1954(a) shall apply to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

Prohibition on the Importation of Potatoes

- 5.—(1) Save as otherwise provided in this Article or in Article 19 the landing of potatoes in Northern Ireland is prohibited.
- (2) The prohibition contained in the preceding paragraph shall not apply to—
 - (a) new potatoes in respect of which the requirements set out in Articles 6 and 7 have been complied with;
 - (b) potatoes produced in the Irish Republic which are being moved through Northern Ireland to a place outside Northern Ireland provided they are moved direct from the point of entry to the point of exit and are not unloaded elsewhere in Northern Ireland.

Importation of New Potatoes

- 6. New potatoes may be landed in Northern Ireland provided that—
- (1) they were before importation into Northern Ireland landed in Great Britain in accordance with the importation regulations governing such landing; or
 - (2) (a) they were produced in any of the countries or parts of countries referred to in the First Column of the First Schedule and are landed in Northern Ireland in any year during the period set out in the Second Column of that Schedule opposite the name of the country or part of a country in which they were grown; and
 - (b) they are accompanied by a phytosanitary certificate and, where appropriate, by one or more supplemental certificates, in accordance with Articles 8 to 10 of this Order; and

- (c) the conditions set out in the Second Schedule are complied with; or
- (3) (a) they were produced in the Irish Republic in a district other than a prohibited district as described in the Sixth Schedule and are accompanied by a certificate in the form set out in the Seventh Schedule; and
- (b) they are landed in Northern Ireland by a route approved by Her Majesty's Commissioners of Customs and Excise and between the hours specified by the said Commissioners for the importation of goods from the Irish Republic.

Provisions as to Containers

- 7.—(1) All new potatoes landed in Northern Ireland shall be securely packed in new bags or other new containers clearly marked with the name of the country in which the potatoes were grown.
- (2) New potatoes landed in Northern Ireland shall not be removed from the containers in which they were landed except for the purpose of sale by retail.

Phytosanitary Certificates

- 8.—(1) Where it is required by Article 6(2)(b) that a phytosanitary certificate accompany a consignment of new potatoes landed in Northern Ireland, such certificate shall be in the form set out in the Third Schedule to this Order, except that, where a consignment is accompanied by a supplemental certificate in accordance with Article 9 of this Order, a facsimile copy of the phytosanitary certificate, endorsed by the Plant Protection Service of the country in which the potatoes were unloaded or landed as being a true copy, may accompany the potatoes in place of the phytosanitary certificate itself.
- (2) The examination referred to in the phytosanitary certificate shall have been carried out not more than 14 days prior to the date of despatch of the consignment.
- (3) The phytosanitary certificate shall have been duly completed and signed by or on behalf of an authorised officer of the Plant Protection Service of the country in which the potatoes were grown.
- (4) If, in the description of the consignment in the phytosanitary certificate, the address of the consignee is not in Northern Ireland, the certificate shall include an additional declaration by the said authorised officer to the effect that the consignment is believed to conform with the current phytosanitary regulations of Northern Ireland.

Supplemental Certificates

- 9.—(1) Where it is required by Article 6(2)(b) that a phytosanitary certificate accompany a consignment of new potatoes landed in Northern Ireland, and where the consignment before being so landed was unloaded or landed in a country or countries other than that in which they were grown and other than in England, Wales or Scotland, such certificate shall be accompanied by a supplemental certificate in the form set out in the Fourth Schedule.
- (2) The supplemental certificate shall have been duly completed and signed by or on behalf of an authorised officer of the Plant Protection Service of the country in which the potatoes have been unloaded or landed.

Further Provisions as to Phytosanitary and Supplemental Certificates

- 10.—(1) Where a phytosanitary certificate or a supplemental certificate is issued in a country of which the language is other than English it shall incorporate or be accompanied by a translation into the language of that country, which translation, if it is in a document separate from the certificate, shall have been duly completed and signed by or on behalf of the officer by whom or on whose behalf the certificate was signed.
- (2) Except in the case of consignments imported by post, phytosanitary certificates and supplemental certificates shall be delivered to the proper officer at the same time as, and together with, the entry relating to the consignment:

Provided that in this paragraph the expression "proper officer" has the like meaning as in the Customs and Excise Act 1952(a) and the reference to the entry shall be construed as a reference to the entry, delivery of which is to be made in accordance with the provisions of that Act.

(3) In the case of consignments imported by post such certificates shall be affixed to the package comprising the consignment or, if the consignment consists of more than one package, the certificate shall be affixed to one of the packages and copies thereof affixed to each of the remaining packages.

Further Provisions as to the Importation of New Potatoes from the Irish Republic

- 11.—(1) The certificate required under Article 6(3)(a) shall be dated not earlier than one month before the date of the landing in Northern Ireland of the potatoes referred to in the certificate.
- (2) Article 10(2) and Article 10(3) shall apply to certificates prescribed in Article 6(3)(a) in relation to potatoes produced in the Irish Republic and landed in Northern Ireland in like manner as they do to phytosanitary certificates and supplemental certificates.

Examination and Sampling

- 12. An inspector, upon production if so required of his appointment or authority, may—
 - (a) enter any premises and examine and take samples of any consignment or part of a consignment of potatoes landed or likely to be landed or suspected by him to have been landed or to be likely to be landed in Northern Ireland, whether or not such consignment was or ought to have been accompanied by a certificate required by this Order,
 - (b) for the purposes of such examination, open, authorise any person to open on his behalf or require the importer or the person in charge of the potatoes to open any bag or other container in the consignment or part of a consignment, and
 - (c) if and so far as is necessary for the purposes of such examination, prohibit entirely, or to the extent indicated by him, the movement of any consignment or part of a consignment of potatoes which has been landed or is suspected by him to have been landed in Northern Ireland.

Procedure when potatoes are landed in contravention of this Order

13.—(1) If any consignment or part of a consignment of potatoes is landed in Northern Ireland in contravention of this Order, the potatoes comprising the

consignment or part of a consignment as the case may be shall forthwith be destroyed by and at the expense of the importer unless they are immediately re-exported or are disposed of in accordance with the terms of a licence served on the importer by an inspector.

- (2) Any destruction required by paragraph (1) of this Article shall be carried out by the importer to the satisfaction of an inspector at a place designated by him and, except with his written authority, none of the potatoes shall be moved other than to such place.
- (3) If the importer shall have failed to destroy the potatoes in accordance with paragraph (1) of this Article or if he shall have failed to dispose of the potatoes in accordance with the terms of a licence granted as aforesaid, then, without prejudice to any proceedings under this Order consequent upon such failure, an inspector or a person acting on his instructions may enter any premises in which the potatoes or any of them may be and may remove and destroy them and the cost of taking such steps shall be recoverable by the Ministry from the importer as a civil debt.
- (4) In this Article "potatoes" includes soil, packing materials, bags and other containers.

Procedure in the case of importation of unhealthy potatoes

- 14.—(1) If it appears to an inspector that any potatoes in a consignment or part of a consignment likely to be landed in Northern Ireland are unhealthy, he may serve upon the importer or upon any person in control of the landing or unloading of the potatoes from a vessel or aircraft a notice specifying the manner in which the landing or unloading is to be carried out and the precautions which are to be taken in the course thereof in order to prevent the spread of any pest or disease.
- (2) If it appears to an inspector at any time that any potatoes in a consignment or part of a consignment landed in Northern Ireland are unhealthy, he may serve upon the importer a notice requiring him, within such time and in such manner as may be specified in the notice, to destroy the potatoes comprising the consignment or part of a consignment or such of them as may be so specified.
- (3) Where a notice under paragraph (2) of this Article has been served upon an importer who, within the time specified in the notice for the destruction of the potatoes, makes a request in writing to an inspector that the potatoes may be re-exported or treated at the importer's own expense and risk the inspector may grant a licence authorising, in lieu of the destruction required by the notice, the re-export or treatment of the potatoes or of such of them as may be specified in the licence within such time, in such manner and subject to such conditions as may be so specified.
- (4) If a request is made in accordance with paragraph (3) of this Article the time specified in the notice served under paragraph (2) thereof shall be deemed to be extended until either a licence is granted under the said paragraph (3) or the inspector serves upon the importer notice of refusal to grant such a licence or until such later time as may be specified in writing by the inspector.
- (5) Any destruction required by a notice served under paragraph (2) of this Article and any treatment authorised by a licence granted under paragraph (3) thereof shall be carried out by the importer upon whom the notice is served

or to whom the licence is granted to the satisfaction of an inspector at a place designated by an inspector and, except with the written authority of the inspector, none of the potatoes shall be moved other than to such place.

- (6) If a notice under paragraph (2) of this Article has been served upon an importer and has not been superseded by a licence granted under paragraph (3) thereof and the importer shall have failed to destroy any potatoes as required in the said notice, or if an importer to whom a licence has been granted under paragraph (3) of this Article shall have failed fully to comply with the terms and requirements thereof, then, without prejudice to any proceedings under this Order consequent upon such failure, an inspector or a person acting on his instructions may enter any premises in which the potatoes or any of them may be and may remove and destroy them and the cost of taking such steps shall be recoverable by the Ministry from the importer as a civil debt.
- (7) In this Article "potatoes" includes soil, packing materials, bags and other containers.

Prohibition on the Planting or Sale for Planting of Imported Potatoes

15. Save under and in accordance with the conditions of a licence issued by the Ministry no person shall plant or cause or permit to be planted or sell or offer for sale for planting any potatoes which have been landed in Northern Ireland.

Procedure when Potatoes are Planted or Sold for Planting in Contravention of this Order

16. If potatoes are planted or sold or offered for sale for planting in contravention of this Order an inspector may by the service of a notice on the person in possession or in charge of the potatoes prohibit the use, removal, sale or exposure for sale of the potatoes except in accordance with such conditions as may be laid down in the notice.

Information regarding imported potatoes

17. Every person who has or has had in his possession or under his charge any potatoes which the Ministry or an inspector knows or suspects to have been landed in Northern Ireland, and every person who as auctioneer, salesman or otherwise, has sold or offered for sale any such potatoes shall, if so required by demand in writing by the Ministry or an inspector, give to the said Ministry or inspector, within the time specified in that demand, all such information as he possesses as to the persons who have or have had or are likely to have the said potatoes in their possession or under their custody or control.

Provided that any information given under this Article shall not be available as evidence against the person giving the same in any prosecution under this Order, except in respect of an alleged failure to comply with this Article.

Service of notices

18. For the purposes of this Order, a notice shall be deemed to be served on any person if it is delivered to him personally or left for him at his last known place of abode or business or sent through the post in a letter addressed to him there; and a notice purporting to be signed by an inspector shall be prima facie evidence that it was signed by him,

Licences

19. Notwithstanding any provisions of this Order, any potatoes may be landed in Northern Ireland under and in accordance with the conditions of a licence granted by the Ministry.

Offences

- 20.—(1) Every person who wilfully obstructs or impedes the Ministry or an inspector in the exercise of its or his powers under this Order or who does any act in contravention of this Order, of the terms or conditions of any notice served or licence issued thereunder or of the requirements of, or of a prohibition imposed by the Ministry or an inspector or who fails to do any act which he is required to do by the Ministry or an inspector or by this Order or by any such notice or licence shall be liable on conviction to a penalty not exceeding ten pounds, or in respect of a second or subsequent offence to a penalty not exceeding fifty pounds.
- (2) In order that the penalty for the landing of any potatoes in contravention of this Order shall be such as may be imposed under the Customs and Excise Act 1952, paragraph (1) of this Article shall not apply in respect of any such landing.

SECOND SCHEDULE

Conditions governing the importation of New Potatoes

- 1. The potatoes are free from Colorado beetle (Leptinotarsa decembineata Say) and either
 - (a) during the 12 months preceding the date of the signing of the phytosanitary certificate there was no outbreak of Colorado beetle within a distance of 25 kilometres of the place where the potatoes were grown; or
 - (b) (i) the potatoes were grown in a district where an intensive system of control of Colorado beetle is in operation, and
 - (ii) they were riddled and washed in a packing station which was inspected and approved by the Plant Protection Service of the country in which the potatoes were grown, the said riddling and washing being at all times subject to inspection by an authorised officer of the aforesaid Service, and immediately after riddling and washing the potatoes were packed as required by Article 7 with a label attached to each bag or container stating the name of the packing station or the number allocated to it by the aforesaid Service;
- 2. The potatoes are free from wart disease (Synchytrium endobioticum (Schilb.) Perc.) and were grown on land in which this disease has not occurred at any time and in a region in which physiologic races of wart disease fungus other than the common European race have not occurred at any time.
- 3. The potatoes are free from ring rot (Corynebacterium sepedonicum (Spieck. and Kotth.) Skaptason and Burkholder) and were grown in a region in which the disease does not occur;
- 4. The potatoes are free from tuber moth (Gnorimoschema operculella (Zell.)); and
- 5. The potatoes are substantially free from brown rot (Pseudomonas solanacearum (E. F. Smith) E. F. Smith):

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order consolidates and amends previous Orders dealing with the importation of potatoes into Northern Ireland and the planting of imported potatoes. It prohibits the importation of potatoes unless they are imported in accordance with the conditions of a licence but exceptions are made in the case of—

- (a) new potatoes produced in the Irish Republic;
- (b) potatoes produced in the Irish Republic which are passing through Northern Ireland to some other country; and
- (c) new potatoes coming from other specified countries during specified periods accompanied by a prescribed certificate; or
- (d) new potatoes which have first been imported and allowed to land in Great Britain in accordance with the importation regulations currently in force there.

All new potatoes imported into Northern Ireland must be packed in new bags or other new containers clearly marked to show the country of origin.

The Order also prohibits, except under licence, the planting or sale for planting of all types of imported potatoes.

The Ministry of Agriculture in exercise of the powers conferred on it by Sections 21 and 53 of the Diseases of Animals Act (Northern Ireland) 1958 and of every other power enabling it in that behalf hereby makes the following Order:—

Citation and Commencement

1. This Order may be cited as the Foreign Animals Order (Northern Ireland) 1964 and shall come into operation on the 1st day of June, 1964.

Revocation

2. The Foreign Animals Order (Northern Ireland) 1957(b) is hereby revoked as from the date of the commencement of this Order.
