Supreme Court Fees Order (Northern Ireland) 1965

The Right Honourable The Lord Chief Justice of Northern Ireland and the Treasury in exercise of the powers and authorities vested in them respectively by the Supreme Court of Judicature (Ireland) Acts 1877 to 1897(a), the Government of Ireland Act 1920(b), the General Adaptation of Enactments (Northern Ireland) Order 1921(c) and sections 2 and 3 of the Public Offices Fees Act 1879(d) do hereby, according as the provisions of the said enactments respectively authorise and require them, make and concur in the following Order:—

1. The following amendments shall be made in the First Schedule of the Supreme Court Fees Order (Northern Ireland) 1963(e) dated the 25th June, 1963:—

- (1) In item 7 after the word "summons" the words "except" to the figures "1872" shall be deleted;
- (2) Item 16 shall be deleted and the following item substituted therefor:—

**16.	For stencilled copies	First copy 9d. per page Subsequent copies 4d. per page	The Requisition: Do."

- (3) In item 20 after the word "for" the words "other" to the figures "1872" shall be deleted;
- (4) In item 34 after the word "order" the words from "other" to the figures "1872" shall be deleted;
- (5) In item 76 after the word "payable" the words "or in proceedings under section 6 of the Debtors' Act (Ireland) 1872" shall be added;
- (6) In item 77 after the word "court" the words "except in proceedings under section 6 of the Debtors' Act (Ireland) 1872" shall be added;
- (7) In item 80 after the word "petition" the words "or in proceedings under section 6 of the Debtors' Act (Ireland) 1872" shall be added;

(8) At the end of item 84 there shall be added the following:—

“NOTE: The term ‘composition’ in items 81 and 84 includes cash brought in by a bankrupt for the benefit of his creditors in lieu of or in addition to assets realised.”

2. This Order may be cited as the Supreme Court Fees (Amendment) Order (Northern Ireland) 1965, and shall come into force on the first day of June, 1965.
