(d) the quantity of such eggs, if any, sold by that person whilst in such storage, the date of any such sale, the name and address of the purchaser and whether the eggs were, before sale, marked in the manner prescribed by paragraph (3) or kept in a container marked in the manner prescribed by paragraph (4).

(8) Every record required to be kept under paragraphs (6) and (7) shall be kept for at least two years from the date to which it applies."

### LEGAL AID AND ADVICE ACT (NORTHERN IRELAND) 1965

#### **Date of Commencement**

Order, dated 26th October, 1965, made by the Minister of Home Affairs under Section 34(2) of the Legal Aid and Advice Act (Northern Ireland) 1965.

I, the Right Honourable Robert William Brian McConnell, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section 34(2) of the Legal Aid and Advice Act (Northern Ireland) 1965(a) (hereinafter referred to as "the Act") do hereby order as follows:—

1. The provisions of the Act specified in the first column of the Schedule for the purpose only of—

- (a) making legal aid available in connection with proceedings-
  - (i) in the House of Lords in exercise of its jurisdiction in relation to appeals from the Court of Appeal;
  - (ii) in the Judicial Committee of the Privy Council in relation to any appeal or reference from Northern Ireland under sections 51 or 52 of the Government of Ireland Act 1920(b);
  - (iii) in the Supreme Court (including a court of assize hearing an appeal under section 1 of the County Court Appeals Act (Northern Ireland) 1964(c);
  - (iv) before any person to whom a case is referred in whole or in part by any of the courts mentioned above;
  - (v) before an under-sheriff under a writ of inquiry; and
- (b) making legal aid available in taking steps to assert or dispute claims to which section 5 of the Act applies;

shall come into operation on the first day of November, 1965.

2. This Order may be cited as the Legal Aid and Advice Act (Northern Ireland) 1965 (Date of Commencement) No. 2 Order (Northern Ireland) 1965.
