## EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

Subject to affirmative resolution of the Commons this Order provides, with effect from the passing of the resolution, that the overall limit on loans which may be made by the Ministry of Commerce under the provisions of the Shipbuilding Industry (Loans) Act (Northern Ireland) 1966 shall be increased from £2,500,000 to £3,500,000.

#### **Gortin Glen Forest Park**

REGULATION, DATED 26TH APRIL 1967, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 14 OF THE FORESTRY ACT (NORTHERN IRELAND) 1953.

The Ministry of Agriculture for Northern Ireland, in exercise of the powers conferred upon it by Section 14 of the Forestry Act (Northern Ireland) 1953(a) and of all other powers enabling it in that behalf, and with the consent of the Ministry of Finance for Northern Ireland, hereby makes the following Regulation—

1. This Regulation may be cited as the Forestry (Gortin Glen) Regulation (Northern Ireland) 1967 and shall come into operation on 12th day of June 1967.

#### Forestry

2. In this Regulation, unless the context otherwise requires, the following expressions have the meaning hereby assigned to them, that is to say:

"the Act" means the Forestry Act (Northern Ireland) 1953;

"the Ministry" means the Ministry of Agriculture.

3. Whereas by Section 14 of the Act it is provided that the Ministry may, subject to the consent of the Ministry of Finance, declare that any land owned by the Ministry shall be treated as a Northern Ireland Forest Park (hereinafter referred to as "a forest park") and thereupon the public shall have access to that land.

Now, therefore, the Ministry hereby declares that the following parts of those lands owned by it and commonly known as Gortin Glen Forest situated in the townlands of Lislap East and Cullion, in the Barony of Strabane Upper in the Administrative County of Tyrone namely:

- (a) that part of the townland of Lislap East containing 300 acres, or thereabouts, statute measure, which is bounded on the west by the County road, B.48, leading from Omagh to Gortin; and
- (b) that part of the townland of Cullion containing 875 acres, or thereabouts, statute measure, which lies within Gortin Glen Forest to the east of the said County road,

as delineated by a red line on the map sealed with the Official Seal of the Ministry on the same date as this Regulation and deposited at the offices of the Ministry at Dundonald House in the County of Down shall be a forest park to which, subject to and in accordance with such bye-laws as may be made, the public shall have access.

### EXPLANATORY NOTE

(This Note is not part of the Regulation but is intended to indicate its general purport.)

Section 14 of the Forestry Act (Northern Ireland) 1953 provides that the Ministry, with the consent of the Ministry of Finance, may by Regulation declare that any land owned by the Ministry shall be treated as a Northern Ireland Forest Park to which the public shall have access. This Regulation accordingly declares that part of Gortin Glen Forest in County Tyrone, totalling about 1175 acres, shall be a forest park within the meaning of the Act.
