**ROAD FREIGHT TRANSPORT LICENSING****Exemption**

REGULATIONS, DATED 12TH JUNE 1969, MADE BY THE MINISTRY OF DEVELOPMENT UNDER SECTION 45(i) OF THE TRANSPORT ACT (NORTHERN IRELAND) 1967.

The Ministry of Development in exercise of the powers vested in it by section 45(i) of the Transport Act (Northern Ireland) 1967(a) and of all other powers enabling it in that behalf hereby makes the following Regulations:—

*Citation*

1. These Regulations may be cited as the Road Freight Transport Licensing (Exemption) Regulations (Northern Ireland) 1969.

*Exemption from Licensing Requirements*

2. The provisions of section 17(2) of the Transport Act (Northern Ireland) 1967 (which prohibits the use of a motor vehicle on a road to carry goods for reward except under a road freight vehicle licence) shall not apply to or affect a motor vehicle which, if used in Great Britain for purposes and in circumstances corresponding to those for which it is being used in Northern Ireland, would, by virtue of regulations made for the purpose of implementing any agreement relating to the international carriage of goods by road which has been applied to Northern Ireland, be exempt from the requirement to obtain a carrier's licence under section 164 of the Road Traffic Act 1960(b).

**EXPLANATORY NOTE**

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

These Regulations exempt from the requirement to hold road freight vehicle licences operators using vehicles brought temporarily into Northern Ireland for the carriage of goods for reward to and from foreign countries.

The Regulations give effect in Northern Ireland to the terms of Agreements which have been made between the Government of the United Kingdom of Great Britain and Northern Ireland and the Governments of other territories, and which are applied to Northern Ireland with the consent of the Northern Ireland Government.

## AGRICULTURAL MARKETING

## Pigs

ORDER, DATED 13TH JUNE 1969, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 2(4) OF THE AGRICULTURAL MARKETING ACT (NORTHERN IRELAND) 1964(a).

The Ministry of Agriculture, after such consultation as is required and in exercise of the powers conferred by Section 2(4) of the Agricultural Marketing Act (Northern Ireland) 1964, hereby makes the following Order:—

*Citation and Commencement*

1. This Order may be cited as the Pigs Marketing Scheme (Amendment) Order (Northern Ireland) 1969.

*Amendment of Scheme*

2. The Pigs Marketing Scheme (Northern Ireland) 1933(b) is hereby amended as follows:—

- (1) In Article 22(2) after the word "June" there shall be inserted: "(but in the case of the election to be held in 1969, the third Tuesday in June)".
- (2) In Article 22(6) after the word "held" there shall be inserted: "(except in the case of the election to be held in 1969 when the date shall be 30th June)".
