## Training Scholarships

REGULATIONS, DATED 30TH APRIL 1970, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 59 and 77 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance hereby makes the following Regulations:—

1. These Regulations may be cited as the Training of Teachers (Scholarships) Amending Regulations (Northern Ireland) 1970.
2. The existing Regulations hereby amended are the Training of Teachers (Scholarships) Regulations (Northern Ireland) 1968(b).
3. The proviso to sub-paragraph 3(3)(c)(i) of the First Schedule to the existing Regulations is hereby revoked.
4. The following sub-paragraph shall be added after sub-paragraph 4(2) of the Second Schedule to the existing Regulations:—

"(3) Except where in the Ministry's opinion hardship would otherwise occur dependants' grants in respect of the spouse and children of a student shall not be payable unless the student has married before the commencement of the course."
5. The value of an award held under the existing Regulations shall be determined either under the provisions of the existing Regulations or under the provisions of the existing Regulations as amended by these Regulations whichever is the more advantageous to the student.

## EXPLANATORY NOTE

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

The purpose of these Regulations is—

- (i) to enable the Ministry, where in its opinion hardship would otherwise occur, to pay dependants' grants in respect of the spouse and children of a student although the student was not married before the commencement of the course; and
- (ii) to remove a "mature" student's entitlement to dependants' grants in respect of a spouse and children unless the student was married before the commencement of the course.
