Amendment of Fees

REGULATIONS, DATED 1ST JULY 1971, MADE BY THE REGISTRAR OF BUILDING SOCIETIES, WITH THE CONSENT OF THE MINISTRY OF COMMERCE, UNDER SECTION 123(1) OF THE BUILDING SOCIETIES ACT (NORTHERN IRELAND) 1967.

The Registrar, with the consent of the Ministry of Commerce, in exercise of the powers conferred upon him by section 123(1) of the Building Societies Act (Northern Ireland) 1967(a), hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Building Societies (Amendment of Fees) Regulations (Northern Ireland) 1971.

Amendment of fees

2. The Building Societies (Forms and Fees) Regulations (Northern Ireland) 1968(b) shall be amended by substituting for Schedule 2 thereto the following Schedule:—
