## SUMMARY JURISDICTION

## Petty Sessions Districts and Times

ORDER, DATED 8TH NOVEMBER 1971, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 21(3) OF THE MAGISTRATES' COURTS ACT (NORTHERN IRELAND) 1964.

The Ministry of Home Affairs in exercise of the powers conferred on it by Section 21(3) of the Magistrates' Courts Act (Northern Ireland) 1964(a) and of all other powers enabling it in that behalf, after consultation with the County Court Judges and Resident Magistrates concerned, hereby orders and directs as follows:—

*Citation and commencement*

1. This Order may be cited as the Petty Sessions Districts and Times (No. 3) Order (Northern Ireland) 1971 and shall come into operation on the 1st day of December 1971.

*Times of holding of Antrim, Ballycastle, Ballyclare, Ballymena, Ballymoney, Carrickfergus, Cushendall, Larne, Newtownabbey, Kilrea and Plumbridge Petty Sessions*

2. Petty Sessions shall be held regularly for the Antrim, Ballycastle, Ballyclare, Ballymena, Ballymoney, Carrickfergus, Cushendall, Larne, Newtownabbey, Kilrea and Plumbridge Petty Sessions Districts at the times set out in the First Schedule.

*Revocations*

3. The Orders specified in the first column of the Second Schedule(b)(c)(d)(e) are hereby revoked to the extent specified in the second column of that Schedule.
