#### Revocation of Commencement Order

ORDER\*, DATED 17TH DECEMBER 1971, MADE BY THE MINISTER OF HEALTH AND SOCIAL SERVICES UNDER THE NATIONAL INSURANCE (No. 2) ACT (NORTHERN IRELAND) 1966.

WHEREAS it is provided by section 14(4) of the National Insurance (No. 2) Act (Northern Ireland) 1966(a) that that Act shall come into force on such day or days as the Minister of Health and Social Services may by order appoint:

AND WHEREAS by the National Insurance (Commencement) (No. 2) Order (Northern Ireland) 1971(b) the Minister of Health and Social Services appointed 1st January 1972 as the day for the coming into force of section 3(2) of the said National Insurance (No. 2) Act (Northern Ireland) 1966, as amended by section 1(1) of the National Insurance &c. Act (Northern Ireland) 1969(c):

AND WHEREAS it is provided by section 17(2) of the Interpretation Act (Northern Ireland) 1954(d) that where an enactment confers a power to make any statutory instrument the power shall be construed as including power, exercisable in the like manner and subject to the like consent and conditions, if any, to amend, alter, rescind or revoke that instrument:

Now, THEREFORE, I, the Right Honourable William Kennedy Fitzsimmons, Minister of Health and Social Services, hereby make the following order:

- 1. The National Insurance (Commencement) (No. 2) Order (Northern Ireland) 1971 is hereby revoked.
- 2. This order may be cited as the National Insurance (Revocation) Order (Northern Ireland) 1971.

#### EXPLANATORY NOTE

(This note is not part of the order, but is intended to indicate its general purport.)

This order revokes the National Insurance (Commencement) (No. 2) Order (Northern Ireland) 1971 which would have brought into force on 1st January 1972 the provisions of section 3(2) of the National Insurance (No. 2) Act (Northern Ireland) 1966. Section 3(2) applies section 3(1) of that Act to flatrate unemployment benefit; section 3(1) deals with days not to be treated as days of unemployment where employment is suspended and is already in force in its application to earnings-related supplement.
