## Colleges of Education: Salaries and Allowances

REGULATIONS, DATED 4TH FEBRUARY 1972, -MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1971 AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the College of Education Teachers (Salaries and Allowances) Amending Regulations (Northern Ireland) 1972.

(2) These Regulations shall be deemed to have come into operation on 1st April 1971.

2. The existing Regulations hereby amended are the College of Education Teachers (Salaries and Allowances) Regulations No. 2 (Northern Ireland) 1970(b).

3. For the purposes of these Regulations—

"approved" means approved by the Ministry for the purpose of these Regulations;

"College of Education" means Stranmillis College, St. Mary's College of Education and St. Joseph's College of Education.

4. A full-time assistant lecturer, lecturer, senior lecturer or principal lecturer who was in service on 1st April 1971 in a college of education shall have his remuneration increased as set out hereunder in respect of any period of service as a full-time assistant lecturer, lecturer, senior lecturer or principal lecturer employed in a college of education on and after that date.

The following shall be increased by 10 per cent:—

(a) the rate payable on the appropriate salary scale set out in the Schedule of the existing Regulations;

(b) any approved allowance payable to a principal lecturer under the terms of Regulation 14 of the existing Regulations in respect of any period from and including 1st April 1971 provided that if the allowance so increased would exceed £840 per annum the amount of the increase shall be such that the aggregate of the allowance and the increase is £840 per annum.

5. Where the remuneration has been increased as provided for under Regulation 4 the rate of such remuneration shall be the aggregate amount rounded to the nearest whole pound, an amount of 50p being rounded up,

### EXPLANATORY NOTE

*(This note is not part of the Regulations, but is intended to indicate their general purport.)*

These Regulations provide that the scale salary of assistant lecturers, lecturers, senior lecturers and principal lecturers who were in service on 1st April 1971 shall be increased by 10 per cent. The Regulations also provide in the case of principal lecturers who were in service on that date that certain allowances shall be increased by 10 per cent.
