### Aid to Industry (Amendment and Revocation) Order (Northern Ireland) 1973

Made

9th October 1973 . 31st December 1973 Coming into operation To be laid before the Parliament of the United Kingdom under paragraph 4(5)(b) of the Schedule to the Northern Ireland (Temporary Provisions) Act 1972

WHEREAS by subsection 1(a) of section 1 of the Northern Ireland (Temporary Provisions) Act 1972(a) it is provided that so long as that section has effect all functions which apart from that Act belong to any Minister of Northern Ireland shall be discharged by the Secretary of State:

Now, THEREFORE, the Secretary of State in exercise of the powers conferred upon the Minister of Commerce and the Minister of Finance by section 1 of the Aid to Industry Act (Northern Ireland) 1961(b) and by virtue of section 1(1) of the Northern Ireland (Temporary Provisions) Act 1972 hereby makes the following Order: ----

#### Citation and commencement

1. This Order may be cited as the Aid to Industry (Amendment and Revocation) Order (Northern Ireland) 1973 and shall come into operation on 31st December 1973.

#### Amendment

2. Article 3 of the Aid to Industry Order (Northern Ireland) 1964(c) shall be amended by inserting after paragraph (1) the following paragraph:-

"(1)(A) No person shall be put on the register under paragraph (1)after 31st December 1973."

#### Revocation

3.—(1) Subject to paragraph (2) the Aid to Industry Order (Northern Ireland) 1964, the Aid to Industry (Amendment) Order (Northern Ireland) 1971(d) and the Aid to Industry (Amendment) Order (Northern Ireland) 1972(e) shall cease to have effect on 31st December 1974.

(2) Without prejudice to section 28 of the Interpretation Act (Northern Ireland) 1954(f), the provisions of paragraph (1) shall not prevent the payment of contributions by the Ministry of Commerce after 31st December 1974 in respect of the contribution year ending on 31st December 1974.

## Medicines (Feeding Stuffs Additives) Order 1973

This Order has been made by the Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland and the Secretary of State for Northern Ireland, acting jointly, in exercise of their powers under section 104(1) of the Medicines Act 1968.
