The Scottish Ministers give notice under article 5(1) of the Transport and Works (Scotland) Act 2007 (Access to Land by the Scottish Ministers) Order 2008 that they propose to take entry pursuant to that Order to *[details of the land to which entry is required and a plan may be attached where this would be helpful]* for the purposes of *[details of purposes]* in respect of a proposed project to *[the purpose of the project]*.

In the event that the Scottish Ministers determine to take entry to the land following the proposal, article 3(4)(c) of the Transport and Works (Scotland) Act 2007 (Access to Land by the Scottish Ministers) Order 2008 provides that such entry is subject to the terms of any agreement between you and the Scottish Ministers regarding entry to the land. *[Delete this paragraph if no such agreement has been entered into between the Scottish Ministers and the recipient of the notice]*

Any representations about the proposal should be sent to the Scottish Ministers, c/o Transport and Works Unit *[postal and e-mail address]*. Representations **MUST** (i) be received by the Scottish Ministers on or before *[expiry date for representations being a date not less than 28 days after the date of the notice]*, (ii) be made in writing (whether sent by post or e-mail), (iii) state the grounds of the representations, (iv) indicate who is making the representations, and (v) give an address to which any correspondence relating to the representations may be sent. (If you are sending your representations by e-mail, please also provide a postal address).

The Scottish Ministers may make complete copies of the representations public.
