This Order is made in exercise of the powers conferred by section 15(1) and (2) of the Scotland Act  $1998(\mathbf{a})$  and all other powers enabling Her Majesty to do so.

In accordance with section 115(1) of, and paragraphs 1 and 2 of Schedule 7 to, that Act a draft of this Order was laid before and approved by resolution of the Scottish Parliament(**b**).

Accordingly, Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows:

#### Citation and commencement

**1.** This Order may be cited as the Scottish Parliament (Disqualification) Order 2015 and comes into force on the day after the day on which it is made.

#### **Specified office-holders**

- **2.** An office-holder of a description specified in Part 1 of the Schedule is disqualified from being a member of the Scottish Parliament.
- **3.** An office-holder of a description specified in column 1 of Part 2 of the Schedule is disqualified from being a member of the Scottish Parliament for any constituency specified in relation to that office-holder in column 2 of that Part of the Schedule and for any region specified in relation to that office-holder in column 3 of that Part of the Schedule.

## Revocation of the Scottish Parliament (Disqualification) Order 2010

**4.** The Scottish Parliament (Disqualification) Order 2010(a) is revoked.
