#### Citation and commencement

**1.** These Regulations may be cited as the Legal Aid (Scotland) Act 1986 Amendment Regulations 2016 and come into force on 1st December 2016.

## Proceedings in which civil legal aid is available

**2.** In paragraph 1 of Part I of schedule 2 of the Legal Aid (Scotland) Act 1986(**b**) (courts in which civil legal aid is available), before the entry relating to the Upper Tribunal insert—

"in or with respect to an appeal to the Upper Tribunal for Scotland(c) (including an application for permission to appeal);".
