The National Health Service (Penalty Charge) (Scotland) Regulations 1999

Made	14th October 1999
Laid before the Scottish	
Parliament	21st October 1999
Coming into force	16th November 1999

The Scottish Ministers, in exercise of powers conferred on them bysections 99ZB(1), (2), (4) and (5), 105(7) and 108(1) of the NationalHealth Service (Scotland) Act 1978(1), and of all other powersenabling them in that behalf, hereby make the following Regulations:

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the National Health Service (PenaltyCharge) (Scotland) Regulations 1999 and shall come into force on 16thNovember 1999.

(2) In these Regulations, unless the context otherwise requires-

"the Act" means the National Health Service (Scotland) Act 1978; and

"surcharge" has the meaning given in regulation 4 of these Regulations.

Service of a penalty notice

2.—(1) Where a person fails to pay any amount referred to in section99ZB(1)(a) or (b) of the Act(2), the responsible authority mayserve a penalty notice requiring the person, within the period of 28 daysbeginning with the date on which the penalty notice was sent, to pay thatamount to the responsible authority together with a penalty chargedetermined in accordance with regulation 3 of these Regulations.

- (2) A penalty notice shall be sent by post to the person's last known address.
- (3) The penalty notice shall state-
 - (a) the name of the person liable to pay the amount required to be paidunder the penalty notice;
 - (b) the amount recoverable as mentioned in section 99ZB(1)(a) or (b) of theAct;
 - (c) the amount of the penalty charge calculated in accordance with regulation 3 of these Regulations;
 - (d) the sum of the amounts referred to in sub-paragraphs (b) and (c), which shall represent the total amount required to be paid under the penaltynotice;
 - (e) in relation to the total amount required to be paid under the penaltynotice-
 - (i) the responsible authority to whom that amount shall be paid;
 - (ii) the address to which that amount shall be sent;
 - (iii) the methods by which payment may be made; and
 - (iv) in accordance with paragraph (1), the date by which that amount shallbe paid to the responsible authority;
 - (f) that if the person fails to pay the amount he is required to pay by the ate specified in the penalty notice-
 - (i) the person must also pay to the responsible authority a surcharge; and
 - (ii) the amount of the surcharge he must pay, calculated in accordance with regulation 4(2) of these Regulations; and
 - (g) that a person is not liable by virtue of a penalty notice-
 - (i) to pay at any time so much of any amount referred to in section99ZB(1)(a) or (b) of the Act for which he is jointly and severally liable with another person as at that time has been paid, or ordered by a court tobe paid, by that other person(**3**), or
 - (ii) to a penalty charge, or a surcharge, if he shows that he did not actwrongfully, or with any lack of care, in respect of the amount recoverableas mentioned in section 99ZB(1)(a) or (b) of the Act(4).

Calculation of penalty charge

- 3. The amount of the penalty charge shall be whichever is the smallerof-
 - (a) £100, and
 - (b) the amount referred to in section 99ZB(1)(a) or (b) of the Actmultiplied by 5.

Surcharge

4.—(1) Where a person fails to pay the amount required to be paid under the penalty notice in accordance with regulation 2(1) of these Regulations, he shall in addition be liable to pay to the responsible authority a further sum (in these Regulations referred to as "a surcharge"), calculated inaccordance with paragraph (2).

(2) The amount of the surcharge shall be 50% of the amount of the penalty charge (rounded down, where necessary, to the nearest whole penny).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations make provision for a civil penalty to be imposedwhere a person fails to pay a National Health Service ("NHS") chargein respect of the provision of drugs and medicines, dental treatment andappliances, optical services, or any other appliances, or receives apayment or benefit towards the cost of a NHS charge or service to which heis not entitled, such as NHS spectacle vouchers or free NHS sight tests.

Regulation 2 provides for a penalty notice to be issued to a personrequiring payment of the amount that the person has failed to pay and anadditional penalty charge. It sets out the period within which thoseamounts must be paid, and the information that the penalty notice must contain.

Regulation 3 sets out how the amount of the penalty charge payableshall be calculated.

Regulation 4 provides that where the amount required to be paid under the penalty notice is not paid within the period prescribed, a further sumby way of penalty ("a surcharge") must be paid.
