**CONTAMINATION OF FOOD**

**The Food Protection (Emergency Prohibitions)  
(Amnesic Shellfish Poisoning) (Orkney)  
(No. 3) (Scotland) Revocation Order 1999**

*Made - - - - 26th November 1999*

*Laid before the Scottish*

*Parliament - - - - 1st December 1999*

*Coming into force in accordance with article 1*

The Scottish Ministers, in exercise of the powers conferred on them by section 1(1) and (2) and section 24(1) of the Food and Environment Protection Act 1985(1), and of all other powers enabling them in that behalf, hereby make the following Order:

**Citation and commencement**

**1.** This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (Orkney) (No. 3) (Scotland) Revocation Order 1999 and shall come into force at 1630 hours on 26th November 1999.

**Revocation**

**2.** The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (Orkney) (No. 3) (Scotland) Order 1999(2) is revoked.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order revokes the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (Orkney) (No. 3) (Scotland) Order 1999 (“the principal Order”) which prohibited–

- (a) fishing for or taking scallops within the area designated in the Schedule to that Order (article 4);
- (b) movement of such scallops out of that area (article 5); and
- (c) landing, using in the preparation of processing for supply of food of, supplying and other specified activities in relation to, such scallops from the designated area (article 6).

The effect of this Order is to remove the remaining prohibitions in respect of the area of sea designated in the Schedule to the principal Order.
