# The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) <br> Partial Revocation (No. 4) (Scotland) Order 2000

Coming into force in accordance with article 1

The Scottish Ministers, in exercise of the powers conferred on them by section 1(1) and (2) and section 24(3) of the Food and Environment Protection Act 1985(1), and of all other powers enabling them in that behalf, hereby make the following Order:

## Citation and commencement

1. This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) Partial Revocation (No. 4) (Scotland) Order 2000 and shall come into force at 1700 hours on 10th February 2000.

## Interpretation

2. In this Order "the principal Order" means The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (Scotland) Order 1999(2).

## Partial Revocation of the principal Order

3. The principal Order is revoked insofar as it designates any part of the area described in the Schedule to this Order being an area within the area bearing the letter A described in paragraph 1 of the Schedule to the principal Order.

The area of sea lying below high water springs enclosed by a line starting at a point on the south coast of Mull at $56^{\circ} 18.7^{\prime} \mathrm{N} 6^{\circ} \mathrm{W}$; then south to $56^{\circ} 15^{\prime} \mathrm{N} 6^{\circ} \mathrm{W}$; then west to $56^{\circ} 15^{\prime} \mathrm{N} 6^{\circ} 30^{\prime} \mathrm{W}$; then north to $56^{\circ} 30^{\prime} \mathrm{N} 6^{\circ} 30^{\prime} \mathrm{W}$; then west to Scarinish on the east coast of Tiree at $56^{\circ} 30^{\prime} \mathrm{N} 6^{\circ} 48.2^{\prime} \mathrm{W}$; then north and west along the coast of Tiree to a point on the west coast at $56^{\circ} 30^{\prime} \mathrm{N} 6^{\circ} 59^{\prime} \mathrm{W}$; then west to $56^{\circ} 30^{\prime} \mathrm{N} 7^{\circ} \mathrm{W}$; then north to $56^{\circ} 45^{\prime} \mathrm{N} 7^{\circ} \mathrm{W}$; then east to a point on the Scottish mainland at $56^{\circ} 45^{\prime} \mathrm{N} 6^{\circ} 11.3^{\prime} \mathrm{W}$ at Sanna; then east and south along the mainland of Scotland to a point at $56^{\circ} 30^{\prime} \mathrm{N}$ $5^{\circ} 27.2^{\prime} \mathrm{W}$ then west to the east shore of Lismore at $56^{\circ} 30^{\prime} \mathrm{N} 5^{\circ} 30.3^{\prime} \mathrm{W}$ then north, west and south to a point on the west shore of Lismore at $56^{\circ} 30^{\prime} \mathrm{N} 5^{\circ} 33.5^{\prime} \mathrm{W}$ then west to a point on the east coast of the Morven peninsula at $56^{\circ} 30^{\prime} \mathrm{N} 5^{\circ} 40.7^{\prime} \mathrm{W}$; then along the shoreline to a point at $56^{\circ} 30^{\prime} \mathrm{N} 5^{\circ} 41.4^{\prime} \mathrm{W}$ then west to a point on the north east coast of Mull at $56^{\circ} 30^{\prime} \mathrm{N} 5^{\circ} 46.4^{\prime} \mathrm{W}$ then west, south and east along the shoreline of Mull to the start point.

## EXPLANATORY NOTE

(This note is not part of the Order)
This Order is the seventh partial revocation of the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (Scotland) Order 1999 (S.S.I. 1999/26) ("the principal Order") which prohibited-
(a) fishing for or taking scallops within the area designated in the Schedule to that Order (article 4 of the principal Order);
(b) movement of such scallops out of that area (article 5 of the principal Order); and
(c) landing, using in the preparation of processing for supply of food of, supplying and other specified activities in relation to, such scallops from the designated area (article 6 of the principal Order).
The effect of this Order is to remove the prohibitions in respect of the areaof sea designated in the Schedule to this Order, which forms part of the area of sea designated as Area A in the Schedule to the principal Order.
