CONTAMINATION OF FOOD

The Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 2) (Scotland) Order 2000

Made--17th August 2000Laid before the Scottish--21st August 2000Parliament---21st August 2000Coming into force in accordance with article 1(1)

The Scottish Ministers, in exercise of the powers conferred on them by section 1(1) and (2) and section 24(3) of the Food and Environment Protection Act 1985(1) and of all other powers enabling them in that behalf, being of the opinion that there exist or may exist circumstances which are likely to create a hazard to human health through human consumption of food and that in consequence food which is derived or may be in the future derived from bivalve molluscs in the areas described in the following Order, is, or may be, or may become, unsuitable for human consumption, hereby make the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Food Protection (Emergency Prohibitions) (Amnesic Shellfish Poisoning) (West Coast) (No. 2) (Scotland) Order 2000 and shall come into force at 1700 hours on 17th August 2000.

(2) In this Order–

- (a) "scallops" means scallops of the class of *pecten maximus;*
- (b) "relevant time" means 0001 hours on 17th August 2000.

Designated circumstances

2. In the opinion of the Scottish Ministers, scallops in the areas designated in article 3 below may be affected by the toxin which causes amnesic shellfish poisoning in human beings and are likely to create a hazard to human health if they are consumed.

Designated areas

3. The areas described in the Schedule to this Order are hereby designated for the purposes of Part I of the Food and Environment Protection Act 1985.

Activity prohibited in the designated areas

4. No person shall fish for or take any scallops in a designated area.

Prohibited movement of scallops

5. No person shall move any scallops out of a designated area.

Restrictions

6. No person shall–

- (a) use any scallops taken out of a designated area after the relevant time in the preparation or processing for supply of food and anything from which food could be derived;
- (b) land any scallops which were in waters in a designated area after the relevant time;
- (c) supply, or have in possession for supply, any scallops which were in a designated area after the relevant time;
- (d) supply, or have in possession for supply, any food or anything from which food could be derived in the preparation or processing of which anything was used in contravention of paragraph (a) of this article; or
- (e) feed to any creature a feeding stuff in the preparation or processing of which anything was used in contravention of paragraph (a) of this article.

THE DESIGNATED AREAS

AREA 1

The area of sea below high water springs enclosed by a line starting from a point at 58° North latitude 5°30' West longitude; then south to the mainland at Gruinard Bay at 57°51.8' North latitude 5°30' West longitude; then south along the mainland shore to 57°30' North latitude 5°52' West longitude; then west to a point on the east coast of Skye at 57°30' North latitude 6°08.8' West longitude; then north, west, south and east around the coast of Skye to 57°15' North latitude 5°39' West longitude; then east to the mainland at 57°15' North latitude 5°38.4' West longitude; then south along the shoreline to 56°41' North latitude 6° West longitude; then south to 56°37' North latitude 6° West longitude; then south to 56°37' North latitude 6° West longitude; then south to 56°37' North latitude 6° West longitude; then south to 56°30' North latitude 6° West longitude; then north to 56°30' North latitude 6° West longitude; then north latitude 6°09' West longitude; then north, west and south-east along the coast of Mull to 56°30' North latitude 6°30' North latitude 6°30' North latitude 6°30' West longitude; then north to 57°45' North latitude 7° West longitude; then east to 57°45' North latitude 6°30' West longitude; then north along the east coast of Lewis to Srianach at 58° North latitude 6°23' West longitude; then east to the point of beginning.

AREA 2

The area of sea below high water springs enclosed by a line starting from a point 56°30' North latitude 5°46.5 West longitude; then east to 56°30' North latitude 5°41.4' West longitude; then east along the shoreline to 56°30' North latitude 5°40.8' West longitude; then east to Rubh Aird Eirinish at 56°30' North latitude 5°30.2' West longitude; then south and east along the Lismore shore to 56°30' North latitude 5°30.2' West longitude; then east to 56°30' North latitude 5°30.2' West longitude; then east to 56°30' North latitude 5°30' West longitude; then south to 56°25.6' North latitude 5°30' West longitude on Kerrera; then west, south and north along the Kerrera shore to 56°24.7' North latitude 5°30' West longitude; then south to 56°15' North latitude 5°37' West longitude; then west to 56°15' North latitude 5°15' North latitude 6° West longitude; then north to the south coast of Mull at 56°19' North latitude 6° West longitude; then east and north along the coast of Mull to the point of beginning

AREA 3

The area of sea below high water springs enclosed by a line starting from a point at 56° North latitude $5^{\circ}40.5'$ West longitude; then west to 56° North latitude $5^{\circ}48.2'$ West longitude on the east coast of Jura; then south along the coast of Jura to $55^{\circ}48'$ North latitude 6° West longitude; then south to $55^{\circ}45'$ North latitude 6° West longitude; then south to $55^{\circ}45'$ North latitude 6° West longitude; then south, west and north to Port Wemyss at $55^{\circ}40.5'$ North latitude $6^{\circ}30'$ West longitude; then south to the point of intersection with the Scottish Adjacent Waters boundary line described in article $3^{\circ}b$) of the Scottish Adjacent Waters Boundaries Order 1999(**2**) on the $6^{\circ}30'$ West line of longitude; then east and south along that boundary line to a point where that boundary line intersects the $55^{\circ}15'$ North latitude $5^{\circ}30'$ West longitude; then north to $55^{\circ}31.6'$ North latitude $5^{\circ}30'$ West longitude; then south, west and north along the shoreline of the Mull of Kintyre to the point of beginning.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, which forms part of Scots law only, contains emergency prohibitions restricting various activities in order to prevent human consumption of food rendered unsuitable for that purpose by virtue of shellfish having been affected by the toxin which causes amnesic shellfish poisoning in human beings.

The Order designates three areas of sea off the west coast of Scotland within which taking scallops is prohibited (articles 3 and 4 and the Schedule). It prohibits the movement of scallops out of those areas (article 5). Other restrictions are imposed in relation to the use of any scallops taken from those areas (article 6).

It is an offence by virtue of section 1(6) of the Food and Environment Protection Act 1985 ("the Act") as read with Schedule 1, paragraph 4 to the Act as inserted by paragraph 10(13) of the Schedule to the Scotland Act 1998 (Modification of Functions) Order 1999 (S.I.1999/1756), to contravene any of the prohibitions contained in this Order anywhere in the United Kingdom or in United Kingdom waters.

Under section 21 of the Act the penalty for contravening an emergency prohibition is-

- (a) on summary conviction, a fine of an amount not exceeding the statutory maximum (at present £5,000);
- (b) on conviction on indictment, an unlimited fine, or imprisonment for a term of not more than two years, or both.

Powers of enforcement in relation to emergency prohibitions are conferred by section 4 of, and Schedule 2 to, the Act. Obstruction of enforcement officers is an offence under paragraph 10 of that Schedule.
