**The Foot-and-Mouth Disease (Scotland) (Declaratory Orders) General Amendment (No. 2) Order 2001**

The Scottish Ministers, in exercise of the powers conferred by article 17(1) of the Foot-and-Mouth Disease Order 1983(1) and of all other powers enabling them in that behalf, hereby make the following Order:

**Citation and commencement**

1. This Order may be cited as the Foot-and-Mouth Disease (Scotland) (Declaratory Orders) General Amendment (No. 2) Order 2001 and shall come into force at 5.00 p.m. on 2nd July 2001.

**Amendment of the Foot-and-Mouth Disease Declaratory (Scotland) Orders 2001**

2.—(1) The Orders referred to in paragraph (2) are amended in accordance with paragraph (3) of this article.

(2) The Orders referred to in paragraph (1) are—

- (a) the Foot-and-Mouth Disease (Scotland) Declaratory (No. 5) Order 2001(2);
- (b) the Foot-and-Mouth Disease (Scotland) Declaratory (No. 6) Order 2001(3); and
- (c) the Foot-and-Mouth Disease (Scotland) Declaratory (No. 7) Order 2001(4).

(3) In paragraph 2(d) of Schedule 2, for “a veterinary inspector” substitute “an inspector”.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order provides that licences for movement of animals direct to approved slaughterhouses out of the infected areas designated by the Foot-and-Mouth Disease (Scotland) Declaratory (No. 5) Order 2001, the Foot-and-Mouth Disease (Scotland) Declaratory (No. 6) Order 2001 and the Foot-and-Mouth Disease (Scotland) Declaratory (No. 7) Order 2001 which may be issued by a veterinary inspector, may also be issued by an inspector appointed by the Scottish Ministers or by a local authority.
