# **SHERIFF COURT**

# Act of Sederunt (Fees of Sheriff Officers) 2002

Made - - - - 21st November 2002 Laid before the Scottish Parliament - - - 25th November 2002 Coming into force - 1st January 2003

The Lords of Council and Session, under and by virtue of the powers conferred upon them by section 40 of the Sheriff Courts (Scotland) Act 1907(1), section 6 of the Execution of Diligence (Scotland) Act 1926(2) and of all other powers enabling them in that behalf, do hereby enact and declare:—

#### Citation and commencement

- 1.—(1) This Act of Sederunt may be cited as the Act of Sederunt (Fees of Sheriff Officers) 2002 and shall come into force on 1st January 2003.
  - (2) This Act of Sederunt shall be inserted in the Books of Sederunt.

#### Amendment of fees

- **2.**—(1) Subject to sub-paragraph (2) below, the Table of Fees in the Schedule to this Act of Sederunt shall be substituted for the Table in Schedule 1 to the Act of Sederunt (Fees of Sheriff Officers) 1994(3) and shall apply to work carried out by a sheriff officer on or after 1 January 2003.
- (2) Sub-paragraph (1) does not affect the fees payable as respects any work so carried out before 1 January 2003.

This Act of Sederunt amends the Schedule to the Act of Sederunt (Fees of Sheriff Officers) 1994 (S.I.1994/392) by increasing the fees payable to sheriff officers by about 2.6%.

The last increase was in the Act of Sederunt (Fees of Sheriff Officers) 2001 (S.S.I. 2001/439).
