The Scottish Ministers, in exercise of the powers conferred by sections 146(2) and 150(2) of the Licensing (Scotland) Act 2005(a) and of all other powers enabling them in that behalf, hereby make the following Order:

1. This Order may be cited as the Licensing (Scotland) Act 2005 (Commencement No. 3) Order 2007.

2. 19th March 2007 is appointed as the day for the coming into force of section 142 of the Licensing (Scotland) Act 2005.

3. 1st May 2007 is appointed as the day for the coming into force of the provisions of the Licensing (Scotland) Act 2005 specified in the Schedule to this Order.
