#### **The Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) Amendment (No. 2) Regulations 2010**

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 16(1), 17, 31 and 48(1) of and paragraphs 1 and 4(b) of Schedule 1 to the Food Safety Act 1990<sup>(1)</sup> and all other powers enabling them to do so.

In accordance with section 48(4A) of that Act, the Scottish Ministers have had regard to relevant advice given by the Food Standards Agency<sup>(2)</sup>.

There has been consultation as required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety<sup>(3)</sup>.

### Citation and commencement

1. These Regulations may be cited as the Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) Amendment (No. 2) Regulations 2010 and come into force on 9th April 2010.

### Amendment of the Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) Amendment Regulations 2010

2. The Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) Amendment Regulations 2010<sup>(4)</sup> are amended in accordance with regulations 3 and 4.

3. In Schedule 1 (Schedule inserted after Schedule 1 to the Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) (No. 2) Regulations 2007<sup>(5)</sup>), for “relevant authority” wherever it appears in the inserted Schedule 1A substitute “food authority”.

4. In Schedule 2 (Schedules inserted after Schedule 8 to the Natural Mineral Water, Spring Water and Bottled Drinking Water (Scotland) (No. 2) Regulations 2007), in the inserted Schedule 9—

(a) in the entry for Ammonium—

(i) in the column headed “Concentration or value”, for “200” substitute “0,50”; and

(ii) in the column headed “Unit”, for “µg/l” substitute “mg/l”; and

(b) in Notes 2, 3 and 4, “parameter” is omitted in each place where it appears.
